


After due deliberations, it is recommended that the following procedures may be adopted to promote, Academic/Research activities:-

1. **Channel for routing proposals:** The proposal duly forwarded by the concerned Head of Department may be routed through the Registrar of the respective University.
2. **Ethical clearance:** For any collaborative research proposal, ethical clearance should be obtained from the respective University.
3. **Funding:** If the project to be done, does not have extra mural sources of funding which will be required to be certified by the Supervisor then in that eventuality free access to the facilities for investigation may be allowed by both the Universities otherwise researcher will have to make the prescribed payment.
4. In case of externally funded research proposals, assets acquired, if any, during the project duration will become the property of the University to which the Principal Investigator belongs.
5. **Training Fee:** Fee for the training, if any, in UHS, Rohtak by students from the MDU, Rohtak and vice-versa may be got waived off from the Competent Authorities.
6. The responsibility of Co-ordinator Inter University Exchange Programme would pass on to the Registrar, MDU, Rohtak w.e.f. 21st Sept. 2016 for a period of one year.


