25. Disaffiliation of PDM College of Technology & Management, Sarai Aurangabad, Bahadurgarh, Distt. Jhajjar

Considered:

- i) the disaffiliation of PDM College of Technology & Management, Sarai Aurangabad, Bahadurgarh, Distt. Jhajjar in view of the NOC issued by the Haryana Government vide letter No. 271-272/Colleges dated 1.4.2016 (Annexure A/28 page 142, already circulated), approval of the AICTE vide letter No. North-West/1-2813807146/2016/Progressive Closure dated 30.4.2016 (Annexure A/29 page 143, already circulated) and the request made by the Director, PDM College of Technology & Management, Sarai Aurangabad, Bahadurgarh, Distt. Jhajjar vide letter No. PDMCTM/2016/2438 dated 30.5.2016 (Annexure A/30 page 144, already circulated). The courses of B.Tech/M.Tech. being run by this college shall be discontinued in stages/progressive manner as per sub clause (d), clause-12 of Statute 38 re-produced below.

"The discontinuation in respect of an integrated course of study/subject for which it is affiliated shall be in stages as under:

- i) In the first year, admission to Part-I class will be discontinued and admission for Part-II, III will continue.
ii) In the 2nd year, admission to Part-II class will be discontinued and admission for Part-III, if any, will continue.
iii) In the 3rd year, there may be no admission."

And

- ii) The following recommendations of the Academic Council made vide Reso. No. 30 of its meeting held on 30.08.2016:

RESOLVED THAT DISAFFILIATION OF ABOVE COLLEGE BE RECOMMENDED TO THE EXECUTIVE COUNCIL FOR APPROVAL AND THAT THE DISAFFILIATION SHALL BE IN PHASES AS PER STATUTE-38.

RESOLVED THAT THE RECOMMENDATIONS OF THE ACADEMIC COUNCIL MADE VIDE RESO. NO.30 OF 30.8.2016 BE APPROVED.
