The fresh Inspection Committee which was constituted by the Vice-Chancellor in terms of decision of Executive Council taken vide Reso. No. 1(VI) of its meeting held on 24-09-2016 to verify the factual position regarding availability of required number of teaching faculty, infrastructure facilities and other support system as per new regulation 2014 of NCTE and to consider the matter of restoration of provisional affiliation of your college in view of restoration of recognition by the Central Body i.e. NCTE for B.Ed. Course w.e.f. the session 2015-16, which visited your college for the purpose and submitted its report (copy enclosed).

The report of the Inspection Committee was placed before the Academic Council of this University and the Academic Council vide Reso. No. 46 of its meeting held on 30-02-2017 resolved as under:-

RESOLVED THAT THE RESTORATION OF PROVISIONAL AFFILIATION OF THE ABOVE COLLEGES BE RECOMMENDED TO THE EXECUTIVE COUNCIL.

The above recommendations of the Academic Council were subsequently placed before the Executive Council and the Executive Council vide Resolution No. 33 of its meeting held on 11.03.2017. approved the above recommendation of the Academic Council.

In view of restoration of recognition by the NCTE and also in terms of above decision of the Executive Council, I have been directed to convey you that Ex-Post Facto Provisional Affiliation of your college is hereby restored for running B.Ed. with an earlier existing intake of 100 seats (2 units) w.e.f. the session 2015-16 subject to the condition that your college shall fulfill all the deficiencies/shortcomings pointed out in the Inspection Report and send compliance of the same to Ch. Ranbir Singh University, Jind for further verification by that University before granting the further continuation in provisional affiliation to the College.
