**Sub: Grant of ex-post facto extension/continuation in provisional affiliation to the existing LLB 3 year and BA LLB 5 year courses in Shamsher Bahadur Saxena College of Law, Makrauli Kalan, Rohtak for/from the session 2014-15 to 2016-17 and also grant of extension/continuation in provisional affiliation for existing law courses for the session 2017-18.**

Sir,

It is to inform you that the Inspection Committee which visited your Institute on 16.8.2017 to verify the availability of infrastructural facilities and other support system required for the courses cited in the subject has submitted its report. The report of the Inspection Committee has been considered by the Vice-Chancellor. On the basis of recommendations made by the Inspection Committee, the Vice-Chancellor has been pleased to grant ex-post facto extension/continuation in provisional affiliation to the existing LLB 3 year and BA LLB 5 year courses with an intake of 120 seats in each for the session 2014-15 and 60 seats in each for the session 2015-16 and 2016-17 in Shamsher Bahadur Saxena College of Law, Makrauli Kalan, Rohtak and also grant of extension/continuation in provisional affiliation for existing law courses with an intake of 60 seats in each for the session 2017-18. This provisional affiliation is subject to approval of Bar Council of India and also subject to the compliance of the deficiencies pointed out by the Inspection Committee. However, the seats reduced by the E.C. vide Resolution No. 72 dated 3.8.2015 can not be restored in the current session (2017-18) since the admission process is already over and the classes are going on for the last one month.

You are, therefore, requested to comply with the deficiencies pointed out by the inspection committee and submit the compliance report to the University upto 30.9.2017 positively. A copy of the inspection report is also enclosed for the purpose.
