

## MAHARSHI DAYANAND UNIVERSITY, ROHTAK

**MINUTES OF THE MEETING OF GRIEVANCES REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 24.08.2018 AT 3.00 P.M. IN THE OFFICE OF THE HEAD, DEPARTMENT OF CHEMISTRY, M.D.UNIVERSITY, ROHTAK TO CONSIDER THE VARIOUS MATTERS RELATING TO ADMISSIONS FOR THE SESSION 2018-19**

Members present:

The Committee discussed the various matters relating to admissions in detail and the following decisions were taken unanimously:-

1. The committee considered the matter with regard to filling up of vacant/left over seats of various PG courses(except UIET) for the session 2018-19 and resolved that the seats vacant/left over and increased seats of some departments be filled up in the last and final physical counselling on 31.08.2018 from the merit list already available with the Department as per reservation policy and procedure mentioned in the Prospectus for session 2018-19.

The supernumerary seats, vacant in any, in the department may also be filled up on the said date from the merit list already available with the department. No fresh application be accepted even if there is no applicant available and seat is vacant.

The concerned Head of the Department will send the position of vacant seats to the Academic Branch as well as to the Director (UCC) upto 29.8.2018 for displaying the same on the University Website for information of all concerned.

Candidates will mark their attendance in the register of the concerned departments from 9.00 a.m. to 11.00 a.m. and after this merit list will be displaced by the concerned department on the notice board of the department. Thereafter, Counselling will commence.

2. Considered the request of Departmental Committee, Deptt. of Defence and Strategic Studies for expostfacto sanction for two seats for admission to M.A. 1<sup>st</sup> semester for the session 2018-19

After detailed discussion the Committee resolved that the full justification be given by the Head, of Defence and Strategic Studies in the matter. It may also be certified that admission of two additional seats have been made as per merit.

3. Considered the recommendation of Departmental Committee of Deptt. of Hindi and History that 10% seat(s) be increased in each course i.e M.A.(Hindi) and M.A.(History) only for the session 2018-19.

Resolved that the requests of the above Departmental Committees be acceded to and the admissions on the increased seats be made on 31.08.2018 as mentioned under item No. 1.

4. Considered the recommendation of Departmental Committee of Deptt. of Economics that 10% seat(s) be increased for 5 year MA(Hons) for the session 2018-19.

The Committee resolved that 5 additional seats be increased for the said course and the admissions against these seats be made as per details given under item. No.1.

5. Considered the recommendations of Head, Deptt. of Psychology with regard to creation 5 additional seats for M.A. (Applied Psychology) in view of the request received from students for the session 2018-19 only.

Resolved that the request of the above Departmental Committee be acceded to and the admissions on the increased seats be made on 31.08.2018 as mentioned under item No. 1.

6. Considered the request of father of a student Dakshita for admission to M.Sc.(Chemistry).

The Head, Deptt. of Chemistry apprised the Committee that the reply of the Legal notice has already been sent by him to the father of the student. Hence, no further action is required in the matter.

7. Considered the case regarding fresh counselling of LLM in view of the Judgment of Hon'ble of Punjab & Haryana High Court.

The Committee noted that as per instructions of the State Government Centralized Online Admission for LLM Course has been conducted by the Kurukshetra University Kurukshetra. Hence, no action can be taken by M.D.University, Rohtak at this stage. The candidate namely Mr. Mahender Singh S/o Sh. Boop Singh has already been admitted in the 2<sup>nd</sup> shift of the LLM Course under Haryana open General Category as informed by the Head Deptt. of Law. Regarding guidelines for reservations for Backward Class(BC and BC-B).

This University has already informed all the Head, of the Department on 16.07.2018 that the guidelines for reservation as at sr. No. 3 and mentioned at page no. 39 in the Prospectus of Centralized Online Admissions published by M.D.University, Rohtak may be followed for all the courses during the session 2018-19. A copy of appendix-D as mentioned on page no. 97 of the Prospectus.

8. Considered the requests of Director, IMSAR and Director, CPAS, Gurugram for opening the University Admission Portal for filling up the vacant seats of

MBA (Business Economics) and 5 years MBA (Hons) respectively for the session 2018-19.

The Committee resolved that the Director, UCC be requested to open the University Admission Portal for inviting fresh applications for filling up the vacant seats up to 30.08.2018 with late fee of Rs.1500/-. The admissions be made on vacant seats on 31.08.2018 as per details given under item no.1.

9. Considered the recommendations of the Admission Committee of Department of Physical Education with regard to gradation certificate required for admission to B.P.Ed. Course for the session 2018-19 in respect of Ms. Pooja Rani.

The Committee resolved that the certificate attached by the candidate with her application be verified from the Sports Department, by the Head, Department of Physical Education at their own level and admission be granted to the candidate, if the certificate is found in order as per instruction received from the State Government.
