**NOTIFICATION**

While considering the request of left out University retirees /employees, the Director General Higher Education, Haryana Panchkula has desired to intimate the names of eligible University employees/retirees of University who had not opted for Pension Scheme 1997 earlier and now they want to change their option from CPF to Pension Scheme.

Accordingly the retirees/ employees who were appointed in the University services before 1.04.1995 and were/are continuing in service as on 1.04.1995 and had not opted for the Pension Scheme 1997 earlier are hereby advised to send their request(s), in triplicate, to opt for Pension from CPF within 15 days from the issue of this notification, subject to the condition that they have to deposit their CPF Share alongwith upto date interest @ rate applicable on PF from time to time, if the Govt. approves the proposal. **The employees/retirees, who had earlier applied for change of option are also required to apply afresh.** This is the last opportunity to apply for change of their option. No application, in this regard, shall be entertained after the due date, in any circumstances.

**However, it is reiterated that it may not be construed as any offer and the decision on the issue shall purely depend on the approval of the State Government.**
