1. Clause- IV appearing at page 14 and 16 in the Prospectus regarding criteria for preparing merit list for admission to M.Phil/Ph.D. and Award of URS for the session 2018-19 be read as under:-  
Weightage of 5 marks to the candidates (excluding All India Category) who have passed Master's examination/M.Phil examination from Maharishi Dayanand University, Rohtak.
