3. Proper and Smooth Implementation of CBCS

The QAC appreciated that the University has introduced CBCS for all its 2-Year and 3-Year PG programmes by getting the Ordinance for the same approved from the Academic and Executive Councils. However, the office of IQAC should sincerely address/resolve/clarify various queries/problems of teaching/non-teaching staff and students as and when required. Formal/informal meetings with the faculty members and non-teaching staff be conducted to sensitize them for smooth and proper implementation of CBCS.

The Council noticed that a good number of foundation and open elective courses have been offered by various departments of the University and advocated that some more open/foundation courses including value added courses may also be added in the list already notified by the University.


3. Sensitizing/Promoting Research

The Quality Advisory Council, like preceding years, again emphasised that culture of research should be promoted as per the past practice by motivating teachers to actively participate in the research process. The Council suggested that the teachers should be motivated to publish their papers in the Web of Science/Scopus/ICI Indexed and UGC approved Journals only.

4. Strengthening of CIL

The members of the QAC suggested that Central Instrumentation Laboratory needs to be strengthened by creating physical infrastructure and appointing Director for the CIL who should be well acquainted with the specifications and functioning of such equipments in the field of laboratories and who may make specific recommendations for making purchases of various instruments.
