In compliance with the orders of the Hon'ble High Court, Chandigarh in the above mentioned CWP, the Vice-Chancellor constituted a committee regarding receiving of RR/CR . The recommendations of the Committee have been approved by the Vice-chancellor. After perusal of various points contained in these requests, it was resolved as under:-

The Institute/Colleges which have obtained stay on the Govt. Notification for affiliation, may be asked to submit the Registration Returns in respect of the Courses being run by these Institutes/Colleges within 10 days with requisite fee without any late fee and fine. Further, it was also resolved that these Institutes be given a week's time for submission of Continuation returns with requisite fee beyond 10 days without late fees. After this stipulated time, the late fee/fine as approved by the University shall be levied on them. For training and guidance regarding RR/CR process you may contact to University Computer Center.

1. You are, therefore, requested kindly to submit the requisite RRs/CRs/Fee as per provisions approved by the University by the stipulated date, within ten days of dispatch of the letter and
2. For transfer of fee/Data from Y.M.C.A University Faridabad to this University be dealt with at your own level.
