I am directed to say that Government is in process of creating/updating the ParivarPehchanPatra (PPP) of all the families including of Government employees and contractual employees in the State to improve the delivery of various services and government interface with citizens. A portal has already been created by NIC for this purpose ([www.meraparivar.haryana.gov.in](http://www.meraparivar.haryana.gov.in)).

Just as government is expected to be a model employer, government employees are expected to be model citizens. All the State Government employees including contractual employees and employees of Boards/Corporations/Universities may, therefore, submit their family details to their respective DDO's and set the pace for this program, that aims at providing various government services to all families apart from expediting development outcomes. The expeditious coverage of families of government employees will act as catalyst for further roll out and coverage of all families in the State.

This advisory may, therefore, please be brought to the notice of all employees including contractual employees of your department. They may be suitably advised to submit the family details to respective DDOs of the department in the prescribed pro-forma at their earliest convenience. This issues in suppression of earlier advice dated 22<sup>nd</sup> July, 2019 on this subject.


