Minutes of the Meeting of Grievance Redressal Committee held on 28.08.2019 at 11:00 A.M. in the office of Dean, Academic Affairs, M. D. University in respect of increasing of seats in the Department of Sociology and to consider the various grievances of students related to admission for the session 2019-20.

During the meeting, following were present:

The committee discussed various issues and following are resolved:

1. On the recommendation of the Departmental Committee of the Department of Sociology, 5 seats are increased in M.A. Sociology (CBCS) in the Department of Sociology for the session 2019-20 and counseling be completed before 31.08.2019 i.e. cut off date for admission to P.G. Courses with late fee of Rs.2000/-.
2. Request of Ms. Sachin Kumari who wants to take admission in M.A. (Education) against Supernumerary Seat against Sports category by giving relaxation the age limit for that category. The request has been withdrawn as the Head, Department of Education has stated that the student has already admitted in M.A.(Education).
3. Request of Mr. Sumit for taking admission in M.A. English 2 Year Programme has not been acceded to as the Departmental Committee of the Department of English and Foreign Languages has resolved that as the number is already too big for a single class so that no more admission be made.
4. Request of students in respect of increasing of seats in M.Sc. (Physics) in the Department of Physics has not been acceded to as the Departmental Committee of the Department of Physics has recommended that in view of the constraints of physical resources including labs, it is not possible to accommodate any request for increase of seats.
5. The Committee considered the request of Ms. Sheetal who wants to take admission in M.A. Psychology against supernumerary seats of single girl child but could not apply within schedule. The Committee after detailed deliberations on the situation of single girls child of widow mother and recommendations of Head, Department of Psychology recommended that the request of Ms. Sheetal may be acceded to for admission in M.A. Psychology on humanitarian grounds against vacant seat meant for supernumerary seats for single girls child category.
