

1. The Committee considered the request received from Mr. Rajesh Sharma a Non-Teaching Employee with regard to admission to Ph.D. Programme in Law against Supernumerary seats for the session 2019-20 in view of the Clause – (iii) page – 24 Ph.D .Prospectus 2019-20 which provide as under:

**“One supernumerary seat in each Department is earmarked for admission to the University appointed teachers working on regular basis who are otherwise eligible. If such seat(s) remain vacant in a Department, then it will go to non-teaching employees, if they are otherwise eligible and subject to availability of supervisors”.**

In view of the above provision, Mr. Manvinder Singh Professor UIET has already been admitted against Supernumerary seat. Hence at present there is no vacant seat.

The request of Mr. Rajesh Sharma has been considered by the Committee for admission to Ph.D. in Law against Supernumerary Seat and resolved that admission may be given to him by creating one additional Supernumerary seat **as a special case in anticipation of approval of Academic Council/Executive Council for the session 2019-20 only subject to availability of Supervisor.**

2. The Committee considered the request received from Mr. Rajender Pal Goyal, Additional Distt. & Session Judge, Rohtak and Mr. Himanshu Singh, Sub Divisional Judicial, Magistrate, Mohindergarh with regard to admission to Ph.D. Programme in Law against Supernumerary seats for the session 2019-20 in view of the Clause – (viii) page – 25 of Ph.D .Prospectus 2019-20 which provide as under:

**“Two supernumerary seats in the Department of Law are earmarked for admission to the candidates who are State Govt. Law Officers or Judges. Such candidates are exempted from entrance test provided that they are otherwise eligible”.**

In view of the above provision, two candidates have already been admitted against Supernumerary seat. Hence at present there is no vacant seat.


The request of Mr. Rajender Pal Goyal, Additional Distt. & Session Judge, Rohtak and Mr. Himanshu Singh, Sub Divisional Judicial, Magistrate, Mohindergarh have been considered by the Committee for admission to Ph.D. in Law against Supernumerary Seat and resolved that admission may be given to them by creating two additional Supernumerary seats **as a special case in anticipation of approval of Academic Council/Executive Council for the session 2019-20 only subject to availability of Supervisor.**




3. Considered the request of the HOD (Economics) that the department may be allowed to fill up 2 (two) more seats for M.Phil (Economics) for the session 2019-20 in respect of Dr. Himmat Singh Ratnoo who is on sabbatical leave and he has given the consent for the same and resolved the request of Head Department of Economics may be acceded to. The admissions may be made as per merit and reservation policy mentioned in the Prospectus. The Counselling may be held on 16.12.2019 in the concerned department.
4. Considered the request of Mr. Manmohan Dhonchak District and Session Judge with regard to attending the classes of Ph.D. Course Work in M.D.U.CPAS, Gurugram and resolved that the classes of Ph.D. Course Work be held in the concerned parent department i.e. department of Law, M.D.U. Rohtak as per Ordinance.
5. The Committee considered the request of Mr. Nittin Siwach, Assistant Estt. Non-Teaching Branch for condoning the delay to fillup application form now for Ph.D. admission in Public Administration and resolved that at this belated stage it cannot be acceded to as admissions are already over.
