Sir/Madam,

It is intimated that as per provision mentioned in the Non Centralized Admission Prospectus 2019 for admission to various courses of this University, the instructions regarding Physical Counselling are as under:

1. The date for next counseling for seats remained, if any, after 3rd counseling will be notified by the concerned department. The program-wise availability of seats will be made available on the website admission portal of M. D. University, Rohtak 2019 after the 3rd online counseling.
2. All the eligible candidates are required to appear personally between 9:00 a.m. to 11.30 a.m. on the date notified by the concerned department and mark their presence by putting signatures in that department, if they wish to seek admission. No candidate will be allowed to participate in the physical counseling if he/she arrives after 11:30 a.m.
3. The list of candidates who will mark their presence between 9:00 a.m. to 11:30 a.m. on the notified date will be displayed by the concerned department at 11:45 a.m. and the counseling will start from 11:45 a.m. onwards. The admissions will be made on basis of merit in the respective categories and subject to availability of seats amongst these candidates. The candidates are required to get their documents verified and deposit the full fee on the same day.
4. In case, at the time of this counseling, the seats of various reserved categories remain vacant and no eligible candidate of the reserved categories is available
