1. The Committee confirmed the minutes of the previous meeting of the Faculty of Social Sciences held on 23.03.2018.
2. Agenda item deferred. The same be submitted on prescription of General Ordinance of B.A/B.Sc Pass course and Honours under CBCS.
3. Considered and approved the following recommendations of the P.G. Board of Studies in History made vide Reso. No. ii) of its meeting held on 13.07.2017(Annexure-II, pages 11-13, already circulated)
 - i) Name of the 'Department of History' be changed into 'Department of History and Archaeology'

- ii) Regarding the name of the degree: Nomenclature will remain the same as “Master of Arts (History)”, but the DMC of M.A.3rd and 4th Semesters i.e. M.A. (Final) would mention the name of the option/specialization namely Archaeology, Ancient India, Medieval India and Modern India.

4. Considered and approved the recommendations of the P.G. Board of Studies in Defence and Strategic Studies made vide Reso. No.1 of its meeting held on 27.08.2018 that the eligibility conditions for admission to M.A. (DSS) from the session 2019-20 may be prescribed as under (Annexure-III pages-14-15, already circulated)

However, the left over vacant seats will be filled-up from amongst the students having Bachelor degree in any discipline with atleast 45% in the aggregate (42.75% in case of SC/ST/Blind Visually/Differently Abled etc. candidates). |

In addition to above, the Committee resolved that the above pattern/recommendations be applicable in all the programs under the Faculty of Social Sciences, where no entrance exam is held for admission.

5. The Committee noted the action taken by Vice-Chancellor in approving the following in anticipation of the approval of Faculty of Social Sciences and Academic Council respectively:-

- (i) Introduction of Social Work as an Elective Subject at UG level from the session 2019-20. Further, the subject may be placed in Group-II of the Scheme of Examinations of B.A.Part-I, II and III.
- (ii) The Syllabus and Scheme of Examinations of B.A.(Social Work) Part-I (as an elective subject) from the session 2019-20 (Annexure-IV pages-16-19, already circulated)

6. Item deferred. The Scheme of examination/syllabi of Social Work for BA Part I,II &III be framed as per CBCS.


Further, the Committee resolved that the CBCS scheme be also implemented upto graduate level in all five year integrated courses.
