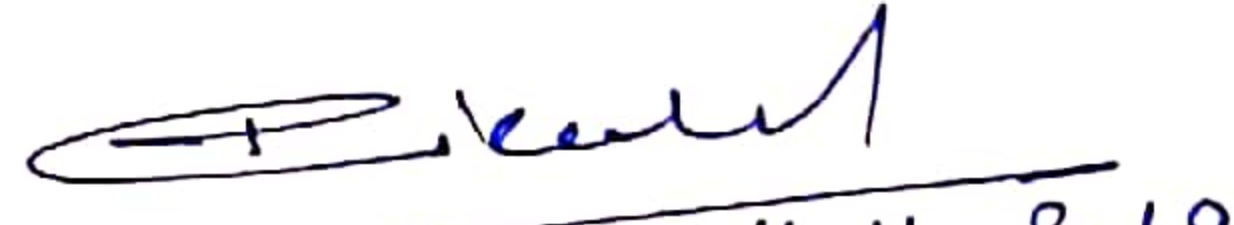

MINUTES OF THE MEETING OF THE COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 24.10.2019 at 11:00 A.M. IN THE OFFICE OF DEAN, ACADEMIC AFFAIRS, M.D. UNIVERSITY, ROHTAK FOR DISCUSSING THE MATTER WITH REGARD TO SCHEME OF EXAMINATIONS OF BBA, B.TECH AND M.TECH COURSES IN R/O COLLEGES WHICH HAVE BEEN TRANSFERRED FROM YMCA UNIVERSITY, FARIDABAD TO M.D.UNIVERSITY, ROHTAK AS PER THE STAY ORDER OF PUNJAB & HARYANA HIGH COURT:-

This committee considered the cases of the four colleges namely Satya College of Engineering & Technology, Palwal, Rattan Institute of Tech. & Mgt., Delhi, Delhi Institute of Tech. Mgt. & Research, Faridabad and BRCM college of Engg. & Tech, VPO Behal which have obtained stay orders from Hon'ble High Court regarding affiliation to this University and are running BBA, B.Tech and M.Tech courses and there is a great need to conduct the exams of these colleges accordingly by this University.

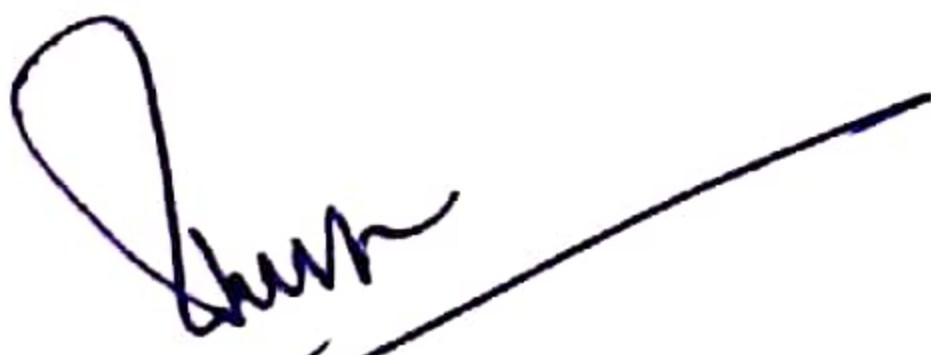
The Committee considered and recommends the following:-

1. This Committee recommends that Scheme and Syllabi of Examination of MDU Rohtak be adopted by all such Colleges.
2. Concerned Universities be requested to provide previous results of the candidates through hard copy as well as soft copy to this University. However, Original documents for the purpose of checking of eligibility & registration of students be also submitted by the concerned College/Institute with R & S Branch of this University, at the earliest.
3. Concerned Principals be requested to communicate their students with clear stipulations that the deficient papers/ subjects will be required to be passed by them according to MDU scheme and syllabus, to become eligible.
4. Concerned Principals be requested to provide cut lists of the previous exams to the Controller of Examinations to be put on record, as enrolled with this University.

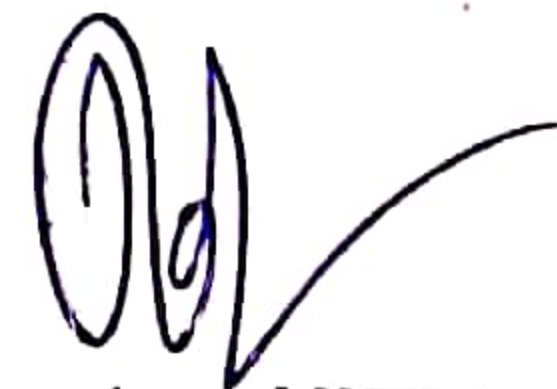

5. In case of similar cases of granting stay by the Hon'ble High Court are received, the same yardsticks may be applicable as highlighted at Point Nos.1 to 4 above.
6. The names of the deficient paper in respect of BBA, B.Tech and M.Tech courses be supplied by the Director, IMSAR and Director, UIET respectively, so that further action may be taken by the Academic Branch and by the concerned Result Branch accordingly.
7. The Committee also noted that the Syllabus and Scheme of Examination of M.Tech (Computer Science & Engineering) and M.Tech (Computer Engineering) are the same. The nomenclature of papers prescribed by MDU alongwith codes as mentioned in the Scheme of Examination in M.Tech (CSE) be followed by the Director, TITs, Bhiwani so that common question papers be got set for all College/Institutes. However the students pursuing this course from TITs, Bhiwani be awarded the degree of M.Tech (Computer Engineering) as they have been granted affiliation to run this course.
