
1. Considered the matter regarding equivalency of Pre-University and B.A 1st year passed from Kurukshetra University, Kurukshetra ^{by} the candidate namely Sh. Dharmbir Singh S/o Sh. Sher Singh during the session 1977 & 1978 respectively be as equivalent to 10+2 level on the basis of information received from Asstt. Registrar (Academic) Kurukshetra University, Kurukshetra vide letter no. ACM/II/19/21061 Dated 04.10.2019. Resolved that the candidate be allowed admission in LLB-1st year (Hons.) 5 year integrated course ^{during the session 2019-20} as a special case by considering equivalent to 10+2 class. However, this may not be considered as a general rule.
2. Considered the matter with regard to equivalency of foreign degrees regarding duration of the course and similarity of papers/ syllabus of the Course for the purpose of admission to higher courses.
Resolved that for deciding the equivalency at least 60-70% syllabus should be matched.
To address the issue with regard to deficient subject ^(S) the concerned department may introduce bridge course ^(S) in respect of Foreign Students.
