NOTICE OF MIGRATION (For Website)

Applications on prescribed Performa alongwith processing fee in the form of Demand Draft/University cash receipt of Rs. 1,000/- (Non-Refundable) are invited from the eligible candidates for migration to MBA, MCA, B.Pharmacy courses and Law Courses in the University Teaching Departments. Selected students will have to pay Rs. 25,000/- as Migration fee if they are enrolled in an affiliated college/Institute of M.D. University or Rs. 30,000/- for Inter University Migration after the migration is allowed.

The applications must reach on or before 23.10.2019 by 5:00 PM in the Registration and Scholarship Branch, M.D. University, Rohtak. The Date of interview will be decided later on and uploaded on the website. The candidates are required to fulfil the following conditions:

1. The candidate who has compartment/re-appear in any subject will not be eligible for migration. However, this condition shall not be applicable to the students who are from the affiliated colleges of M.D. University, Rohtak.
2. Migration to 1st year of the course is not permissible in MBA, MCA and B.Pharmacy Courses. Migration will be allowed against the seats falling vacant within the total intake sanctioned for the particular class in third semester (2year)
3. The duration of course must be the same as in MDU.
4. As per requirement, the candidate seeking migration must have qualified in the entrance test/examination of the University/Institute from which migration is sought and passed qualifying exam recognized by MDU with the minimum marks and the subjects as prescribed for admission to the course by MDU, Rohtak.
5. The candidate will have to produce NOC from the College and also remarks/certificate regarding his/her conduct and behaviour during his/her stay in the institution.
6. The candidate will have to deposit Rs. 1,000/- as application processing fee alongwith the application and Rs. 25,000/- as Migration fee or Rs. 30,000/- for Inter University Migration after migration is allowed.
7. Migration will be allowed against the seats falling vacant within the total intake sanctioned for the particular class at the time of admission to the first year of the course and onwards in law courses.
8. Migration to first year of course is not permissible under any circumstances for MBA, MCA and B.Pharmacy courses.
9. All the candidates who apply for migration must have a valid reason such as compassionate ground- transfer of parents, medical grounds, security reasons and likewise. They are required to submit documentary evidence of the cited reason.

10. The candidates migrating from other Universities must have secured atleast 50% aggregate marks in the 1st year of the course of the University/Institute and should have qualified all the papers (Both theory and practical) in the 1st attempt.
