Subject:- Follow-up action on the Reso. No. 47 of the Executive Council's Meeting held on 04-09-2019- Matter regarding withdrawal of affiliation of the Institute.

Sir/Madam,

This University on the basis of recognition granted by the Central Body i.e. NCTE granted the conditional provisional affiliation to Haryana Institute of Education, Asodha, Tehsil Bahadurgarh, Distt. Jhajjar for running B.Ed. regular course with an intake of 100 seats from the session 2007-08 with certain conditions to be fulfilled by the Management of the said College.

The University was in receipt of a letter from the Chairman of the college in which the college informed the Central Body i.e. NCTE that their college is running B.Ed. Course from since 2007 and the management of college has decided to close the institute from the academic session 2019-20 as per the resolution made by Governing Society. The College further applied for Zero session (i.e. no new admission) in the B.Ed. Course in the last academic session 2018-19 and applied for No Objection Certificate for complete closure from the academic session 2019-20 and requested to make necessary action so that their college should not be included in online counseling for B.Ed. Course from the Academic Session 2019-20 and also requested to provide No Objection Certificate for complete closure of the College.

The college under reference was affiliated with this University for running B.Ed. Regular course with an intake of two unites (100 seats). The State Government has authorized C.R.S.U. Jind as admission making authority for B.Ed. regular course for the session 2019-20. The management of the college has also requested the Dean, C.R.S.U. Jind in this regard and further requested the Regional Director, NCTE for complete Closure of B.Ed. Course in Haryana Institute of Education, Asodha, Tehsil Bahadurgarh, Distt. Jhajjar.

On the request of the society, the matter was placed before the Vice-Chancellor, who in anticipation approval of the Academic Council/Executive Council, has allowed to withdraw the affiliation of the said college i.e. Haryana Institute of Education, Asodha, Distt. Jhajjar for B.Ed. regular course (the college has already in zero session for the session 2018-19 and the final batch of B.Ed. students admitted in the session 2017-18 under this University has also completed) w.e.f. the session 2019-20.

The above action of the Vice-Chancellor was considered by the Executive Council vide Reso. No. 47 of its meeting held on 04-09-2019 and resolved that action taken by the Vice-Chancellor as above be approved.

In the light of above decision of the Executive council I have been directed to inform you that provisional affiliation of your college i.e. Haryana Institute of Education, Asodha, Tehsil Bahadurgarh, Distt. Jhajjar is being withdrawn w.e.f. the session 2019-20 and the admission making authority i.e. Ch. Ranbir Singh University, Jind is also being requested to delete the name of your Institute from the list of Colleges of Education sent by this University for admission to B.Ed. regular course for the session 2019-20.
