
Press Note

It is notified for the information of all concerned that the **Intermediate examinations of B.Pharmacy/M.Pharmacy and LL.B. Programmes** regulated by Pharmacy Council of India and Bar Council of India, respectively will be conducted as per their guidelines in offline (descriptive) mode. Also the 1st year examination of all UG / PG programmes being run through Distance mode and additional examinations of 1st & 2nd year will be conducted in **Offline Descriptive Mode**, following the preventive safety measure of COVID-19 as per guidelines issued by the MHA/State Govt. from time to time. The duration of the Examination will be 1.45 hours. The students have to attempt any three questions carrying equal marks. However, in case of question papers having unequal distribution of marks as in the case in *Hindi, English, Sanskrit, B.Pharmacy etc.*, the students are required to attempt as many parts irrespective of questions of their choice that constitutes of 60% of maximum marks. For example, parts of the questions equivalent to 54 marks out of 90 marks, 48 marks out of 80 marks, etc.

The foreign students or those who are out of Country/Army personnel/COVID positive/Quarantined/Residing under Containment Zone may be allowed to appear through Online Descriptive Mode by the concerned Heads / Directors / Principals of Departments / Institutes / Colleges at their own level. In such cases, the students will be required to request the concerned Heads/Directors/Principals of the concerned Examination Centre or to the Controller of Examinations, with valid reason or valid Medical/containment zone

Certificate, as the case may be, **alongwith their contact No. and e-mail Id and Admit Card at least 24 hours before the start of his/her Examination.** Such students will be given extra 30 minutes on the same pattern as that of PG Terminal Online Descriptive Examination and accordingly they will be required to upload their answer-sheets to their respective Departments/Institutes/Colleges.

However, for the rest of the programmes, Intermediate Semester/Annual examinations will not be conducted and the students shall be promoted and their results of these programmes will be declared.


