



At the outset, the Committee deliberated on the issue with regard to position of vacant seats in P.G. Programs and LL.B. 3 year program as received from various HODs/Directors and decision taken by the Committee vide Reso. No. 2 in its meeting held on 20.11.2020 for considering the candidates for admission on merit basis whose result have been declared by the University (who had appeared in special examination commencing from 23.11.2020) and other similar situated candidates and provided that they had applied for admission in time i.e. upto 16.11.2020 and recommended that 4th round of online counseling be conducted as per following schedule:-

Thereafter the formal Agenda was taken up and the Committee recommended as under:-

1. Considered the requests received from students who had been offered seats for admission to various P.G. Programs and LL.B. 3 year programs in various departments in 1st, 2nd & 3rd round of counseling but could not deposit fee within schedule due to one reason or another. Now, they want to deposit the fee.

RESOLVED THAT THE CANDIDATES WHO HAD BEEN OFFERED SEATS FOR ADMISSION TO VARIOUS P.G. PROGRAMS AND LL.B. 3 YEAR PROGRAMS IN VARIOUS DEPARTMENTS IN 1ST, 2ND & 3RD ROUND OF COUNSELING BUT COULD NOT DEPOSIT THE FEE IN TIME, THEY CAN PARTICIPATE IN 4TH COUNSELING AND THEY SHOULD GIVE THEIR OPTION TO THE CONCERNED HODS/DIRECTORS THROUGH EMAIL UPTO 27.12.2020.

2. Considered the request received from various candidates who could not submit the relevant documents upto 08.12.2020 now they have requested to allow them to submit the relevant documents and may be considered for admission

RESOLVED THAT THE CANDIDATES BE ALLOWED TO UPDATE THEIR RESULT OF QUALIFYING EXAMINATION UPTO 27.12.2020 THROUGH EMAIL TO THE CONCERNED HODs/DIRECTORS OF VARIOUS UTDS AND MDU-CPAS, GURUGRAM AS THE CASE MAY BE. THEY SHOULD UPLOAD THE DMC OF FINAL YEAR EXAMINATION/COMPUTER GENERATED RESULT AVAILABLE ON THE UNIVERSITY WEBSITE.

IF THE REQUEST IS SENT TO ANY OTHER EMAIL OTHER THAN THE EMAIL OF HODs/DIRECTOR OF THE CONCERNED DEPARTMENT/INSTITUTE, THE SAME SHALL NOT BE CONSIDERED.

FURTHER, RESOLVED THAT THE DOCUMENTS WITH REGARD TO RESULT OF QUALIFYING EXAMINATION ONLY BE CONSIDERED AND NO OTHER DOCUMENT BE CONSIDERED AT THIS STAGE

3. Considered the request received from many students to change their categories as under for the purpose of admission to P.G. and LL.B. 3 year program:-
- (i) SC to DSC and vice-versa
 - (ii) Supernumerary to General Category and vice-versa
 - (iii) All India Open to All Haryana Open General and vice-versa
 - (iv) Change of any other category

RESOLVED THAT THE PROPOSAL AS AT SR. NO. (i) & (iii) ONLY BE APPROVED. REGARDING POINT NO. (i), THE GRC REITERATED ITS EARLIER STAND TAKEN VIDE RESO. NO. 2 OF ITS MEETING HELD ON 20.11.2020 AND THE INSTRUCTIONS ISSUED BY THE STATE GOVT. BE IMPLEMENTED IN LETTER AND SPIRIT WHICH HAS ALREADY BEEN SENT BY THE ACADEMIC BRANCH ON 21.11.2020 AND 2ND PARA OF THAT LETTER IS REPRODUCED AS UNDER:-

“Govt. has duly considered the matter and decided that where the Scheduled Caste certificate has been issued earlier the same would also be valid for the purpose of admission in Deprived Scheduled Caste quota provided the candidate should belong to any of the castes mentioned in the list of Deprived Scheduled Caste”.

4. Considered the request of Ms. Yogita Sharma D/o. Sh. Satpal recommended by the HOD (Commerce) to fill up seat under ex-serviceman category as PWD category candidate selected for admission did not deposit fee.

RESOLVED THAT THE ADMISSION COMMITTEE OF COMMERCE DEPARTMENT MAY TAKE ACTION AS PER RULE/PROVISION MENTIONED IN THE PROSPECTUS.

5. Considered the request of Ms. Nidhi who wants to take admission in M.Sc. (Microbiology) but could not submit her qualifying result upto 08.12.2020 in the concerned department as per decision of the University. However, she enclosed internet copy of result dated 10.11.2020 with her request dated 04.12.2020

RESOLVED THAT THE MATTER HAS ALREADY BEEN CONSIDERED VIDE RESO. NO. 1

6. Considered the requests of students recommended by the Director, IMSAR who wants to take admission in MBA 2 year and uploaded his documents before 08.12.2020.

THE ITEM WAS WITHDRAWN.

7. Considered the admission cases of 4/5/6 year's programs in the departments.

RESOLVED THAT FINAL CUT OF DATE FOR ADMISSION TO THE ABOVE MENTIONED PROGRAMS HAS ALREADY BEEN PRESCRIBED AS 30.11.2020 WHICH HAS ALREADY EXPIRED AND AT THIS BELATED STAGE NO ADMISSION BE MADE AS THE MOST OF THE SYLLABI OF THESE PROGRAMS HAVE BEEN REPORTED AS ALMOST COMPLETE/TO BE COMPLETED VERY SOON.
