Dear

Kindly refer to earlier D.O. letter No. PS/FCR & ACS Revenue/5210-5239, dated 20.04.2020 from my predecessor, Mr. Dhanpat Singh and Memo No. Nodal Officer/Rev/Spl-41, dated 28.05.2020 on the above subject vide which you were intimated that complaints received at CPGRAMS (PG Portal) & CM Window Portal are not being disposed of seriously/logically. You were asked to take concrete steps to dispose

of all the pending grievances of CPGRAMS (PG Portal) & CM Window Portal pertaining to the previous years

and upload final action taken reports in respect of such grievances on respective Portals.

2. CPGRAMS (PG Portal) & CM Window Portal are flagship programmes of Central Government and Haryana Government for redressal of public grievances in an expeditious manner. The complaints received on these Portals have to be disposed of within a given time format. However, several complaints pertaining to the previous years are still pending in your office, which shows that due attention is not being paid to this issue. These complaints are being monitored by Sh. Rakesh Cupta, IAS, Project Director, CMGGAs and the Hon'ble Chief Minister also personally monitors the progress of disposal of these complaints. It shows the importance State Government attaches to these programmes. However, despite this, some officers are not taking them seriously, resulting in delay in disposal of these complaints.

I would therefore, again request you to dispose of all the pending grievances of CPGRAMS (PG Portal). & CM Window Portal pertaining to the previous years within a weak positively and send a fortnightly report, failing which I will be constrained to recommend disciplinary action against the officer(s)/official(s) with whom the complaints are found pending beyond prescribed time limit.

4. I would also appreciate if you would look into this matter personally and dispose of all pending complaints of previous years within a week positively and upload the final ATRs as per guidelines issued by the Chief Minister's office.
