**NOTIFICATION OF EXTENSION OF CLOSURE**

In furtherance to our endorsement no. DR/GA/CE/2020/1673-1772 dated 01.06.2020 whereby extension of closure of Maharshi Dayanand University and Colleges under its jurisdiction upto 30.06.2020 was notified. It is informed that the authorities have decided to extend the closure with some controlled functioning upto 31.07.2020 in compliance with the directions issued by the Ministry of Home Affairs, Govt. of India and the communication made by the Principal Secretary to Govt. Haryana, Higher Education Dept. Chandigarh vide Memo No. KW-18/79-2020 UNP (4) dated 01.07.2020. Steps/Measures being taken/adopted by the University in light of the University's earlier notifications dated 13.03.2020 and 23.03.2020 will remain actively enforce during this tenure.

The administrative and ministerial staff in the University will be coming as per the usual protocol for completion of administrative work, except the personnel from containment zone, if any. All will maintain social distancing as per protocol and will strictly follow the national directives for COVID-19 management. There shall be no classroom teaching and physical public dealing during this period.

Faculty members including resource persons will utilize this period for various academic activities as assigned by the University from time to time. They will attend the University, as and when required by the HoDs/Directors/University Authorities, with all precautionary measures as mentioned in the guidelines issued by MHA. Nobody shall leave the headquarters without permission of the competent authority.
