The Committee deliberated upon the different issues that have cropped up due to the outbreak of COVID-19 pandemic and subsequent lockdown since 23 March, 2020. The situation has necessitated alterations/modifications/amendments of various ordinances at relevant places to avoid hardship to students and smooth functioning of the academics. It also considered point no 10 of the UGC guidelines on examinations and academic calendar for the Universities which inter-alia specified:

"...strategies to facilitate the UG/PG students pursuing projects/dissertations, in view of the prevailing circumstances. The universities may consider to assign review-based/secondary data-based projects or software-driven projects, instead of laboratory-based experiments or field/ survey- based assignments to these students".

Resolved to make the following recommendations:

 That point number 10 of the UGC guidelines reproduced as above may be adopted. The HODs may submit proposals specifying existing provisions and proposed changes passed in the Departmental Committee. In addition to this, the suggestions/changes received from time to time from different regulatory/ statutory bodies be adopted wherever applicable.

The last date for submission of online Projects/Dissertations for UG/PG course wherever applicable for the current session i.e. 2019-20 (Even Semester) may be prescribed as 15.07.2020. However, a candidate may submit the same with late fee of Rs. 500/- up to 31.07.2020. The awards should be submitted by August 07, 2020.
 Practical examination and vive year on project reports or discretization in 100000.

Practical examination and viva-voce on project reports, or dissertation in UG/PG Courses, as the case
may be, got conducted by an internal Board of Examiners duly constituted by PGBOS. For UG
programmes, the same may be got conducted at the College level.

 That Online submission of M.Phil. dissertation / Ph.D. thesis may be allowed keeping in view UGC Regulations, 2016. However, the candidate should submit three copies of the dissertations/thesis before the viva-voce exam is held.

That the alterations/modifications/amendments cited from point 1 to 4 above are purely limited to situation arising out of COVID-19 pandemic and would cease to exist thereafter. These may be allowed as one-time measure to off-set the hardships arising out of this contagion pandemic
