

**MINUTES OF THE MEETING OF CBCS BOARD HELD ON 12.03.2020 AT 10:00 AM IN THE COMMITTEE ROOM ADJACENT TO THE REGISTRAR'S OFFICE, M. D. UNIVERSITY, ROHTAK TO CONSIDER THE VARIOUS ISSUES WITH REGARD TO OPEN ELECTIVE COURSES FROM THE SESSION 2019-20 & 2020-21 UNDER CBCS IN VARIOUS DEPARTMENTS.**

The following decisions were taken:

1. The minutes of previous meeting of the CBCS Board held on 27.09.2018 be confirmed.
2. To consider the recommendations of HOD (Statistics) dated 06.02.2020 that the following two Open Elective papers may be included in the list of Open Elective courses for P.G courses under CBCS w.e.f the session 2019-20:-
  - (i) Statistical Programming Using R Language (2<sup>nd</sup> semester).
  - (ii) Official Statistics (3<sup>rd</sup> semester) from the session 2020-21.

**The Committee resolved that the course 'Statistical Programming Using R Language' for 2<sup>nd</sup> semester be approved to be included in the list of Open Elective courses w.e.f 2019-20. However, it be a one time exception for the students of the Department of Statistics for opting this paper as open elective. Further, the course 'Official Statistics' (3<sup>rd</sup> Semester) from the session 2020-21 be approved.**
3. To consider the recommendations of PGBOS in History and Arch. made vide Reso. no. 2 that the following four new papers of Open Elective Subjects under CBCS may be introduced w.e.f session 2020-21:
  - (i) Nationalism in India
  - (ii) Constitutional and Administrative History of India (1858-1950) for 2<sup>nd</sup> sem.
  - (ii) Survey of Sources of Indian History
  - (iv) Cultural Heritage of Haryana in 3<sup>rd</sup> sem.

**The Committee resolved that the course 'Constitutional and Administrative History of India (1858-1950)' for 2<sup>nd</sup> sem. and the course 'Cultural Heritage of Haryana' in 3<sup>rd</sup> semester be approved from the session 2020-21.**





- (ii) Animations

- (iv) Biostatistics and Mathematical Biology
- (v) Mathematical Economics
- (vi) Research Ethics
- (vii) Veda and Srimad Bhagvad - Gita


