



MINUTES OF THE MEETING OF THE GRIEVANCE REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 04.11.2020 AT 3:30 P.M IN THE COMMITTEE ROOM ADJACENT TO THE REGISTRAR'S OFFICE, M.D.UNIVERSITY, ROHTAK WITH REGARD TO CONSIDER THE MATTER IN RESPECT OF EXTENSION OF DATE TO DEPOSIT THE FEE FOR INTERMEDIATE SEMESTER'S STUDENTS AND ADMISSIONS RELATED GRIEVANCES FOR THE SESSION 2020-21.

The Committee deliberated on the following issues and recommended as under:-

1. To consider the request of students of various Departments/Institutes with regard to depositing the fee of intermediate semesters i.e. 3rd, 5th, 7th and 9th who could not pay their semester's fee upto 30.09.2020 due to one or the other reasons.
The Committee considered the requests of the students and circumstances due to COVID-19 Pandemic, recommended that the students be allowed to deposit the fee of intermediate semesters i.e. 3rd, 5th, 7th and 9th upto 20.11.2020 with late fee of Rs. 500/-provided HODs concerned ensure to fulfill deficient teaching requirement.
2. Request received from the Director, IHTM to give permission to invite fresh applications for admission to the Programs run by their Institute to fill up vacant seats.
The Committee considered the request of Director, IHTM and recommended that the Institute be allowed to make admissions as per provision by inviting fresh applications, specifying no of seats vacant, reservation norms. Further, Committee resolved that all process should be completed upto 30.11.2020 following all rules and regulations/reservation policy of the University.
3. To consideration the request of a student, Mr. Mayank, who could not take admission in earlier counseling in MBA 5 Year integrated programs in the Institute of Management Studies & Research, M.D. University, Rohtak.
Committee considered the request of student and same has not been acceded to.
4. The committee considered the request received from the Heads, Departments of the Public Administration., English & Foreign Languages, Economics and Director, MDU-CPAS, Gurugram to fill up vacant seats after 4th round of counseling and seats vacated by the already admitted students, if any from existing aspirants.
The Committee resolved that Departments/Institutes may admit students in the existing merit list up to 12.11.2020 through online Counselling.
