

The Committee deliberated on the issue and resolved as under:-

1. As per Ph.D ordinance 2020-21 Clause - 12 "In case of University appointed teachers, the number of research scholars registered under Supervisor at a given point of time should not be less than 50% of the maximum number of seats a Supervisor can have, except under exceptional circumstances beyond control." Accordingly eligible supervisor must at least get the balance vacant seats advertised in the present academic session. They may, however, take JRF candidate(s) beyond this ceiling of 50%.
2. The departments offering M.Phil may see that at least 10 seats are advertised for the program. The program may be allowed if at least five students take admission.
3. The Academic Branch shall send the draft prospectus to all the members of the committee through e mail so that it may be finalised in the meeting to be held on 16.11.2020
