MINUTES OF THE MEETING OF THE GRIEVANCE REDRESSAL COMMITTEE HELD ON 20.11.2020 AT 3:30 PM IN THE COMMITTEE ROOM ADJACENT OF THE REGISTRAR OFFICE, M.D.UNIVERSITY, ROHTAK TO CONSIDER THE VARIOUS POINTS WITH REGARD TO ADMISSION/CHECKING OF FORMS AND DISPLAYING OF MERIT LIST ETC. FOR PG PROGRAMS AND LL.B 3 YEAR PROGRAM FOR THE SESSION 2020-21.

The Committee deliberated on the following issues and recommended as under:-

1. In view of non functioning of internet/slow speed of the internet in the University Campus and non updates of result of qualifying examination by 30-40% candidates as intimated by various HODs, the Committee recommended that the candidates, who could not upload the required documents including DMC of qualifying of examination be given an opportunity to upload the same upto 25.11.2020 positively. The following notice be got published in the News Paper and be made available on the University website:-

"All the candidates who have applied for admission to P.G. Programs including LL.B (3 Years) Programs offered by University Teaching Departments and MDU-CPAS, Gurugram for the session 2020-21 upto 16.11.2020 are hereby given final opportunity update/correct/change/modify (except reservation category application type category) in their admission form upto 25.11.2020. While updating their application form, the candidate must ensure uploading the computer generated result of the qualifying exam/final semester, in case the DMC is not available. Regarding change of reservation category or application type (supernumerary to general or vice-versa) candidates should send their request to Director, University Computer Centre, M.D. University, Rohtak through E-mail update.admission@mdu.ac.in"

Thereafter, no request shall be entertained in any case.

 Accordingly the Committee recommended revised schedule of admission for PG Programs including LL.B. 3rd year program being run by the UTDs and CPAS as under:-

The candidates who could not appear in the examination through online/offline mode in the terminal semester and have been given a special chance to appear in special examination in offline descriptive mode to those students who appeared in online MCQ examinations held in October, 2020 & their Result is 'UMC' commencing w.e.f. from 23.11.2020 as notified vide Endst. No. Conduct/2020/3739-43 dated 20.11.2020 (copy enclosed) may also be considered on the basis of merit for admission after 3rd merit list only if the seats are vacant in PG Programs and LL.B. 3 year program offered by UTDs and MDU-CPAS, Gurugram provided they have applied for admission in time i.e. 16.11.2020 and their results are declared before the 4th counseling.

- 3. In view of the instructions received from the State Government regarding grant of certificate of Scheduled Caste or Deprived Scheduled Caste vide letter No. 22/27/2019-1GS-III, dated Chandigarh, the 27th October, 2020 (copy enclosed), the Committee recommended that the above letter be sent to all HODs/Directors and MDU-CPAS, Gurugram for taking further necessary action in the matter.
- Considered the requests received from various HODs/Directors for clarifying the matter regarding giving of weightage of 5 marks who have passed graduation examination from the Universities situated in the State of Haryana.

Resolved that weightage of 5 marks be given only to such candidates who have passed graduation/qualifying examination from public funded Universities i.e. State Universities of Haryana.

Considered the requests received from HOD, Political Science regarding providing Technical expert for scrutiny application for admission of PG program.

Resolved that needful be done by the HODs at their own level as Technical expert are not available with the UCC as informed by the Director, UCC in

the meeting. However, the HODs may seek help from other departments if they have shortage of teaching staff.

- 6. The Committee considered the request dated 12.11.2020 for clarification regarding opening of the panel for the students to upload their documents for LL.B-5 year course (copy enclosed).
 - Resolved that the Director, UCC must look into the matter and also ensure that the admission portal/panel is closed after last date and no candidate is allowed to upload the required documents on the admission portal/panel for various programs after the last date notified by the University.
- 7. While considering the requests received from various HODs for approval of schedule of further online counseling (after 3rd counseling), in case of seats remaining vacant, the Academic Branch must ensure that breakup of seats is supplied by the HODs/Directors before the case is submitted to University Authorities.
- The latest Income Certificate issued on or after 01-04-2019 or the same issued by the competent authority of Haryana Government may be accepted, wherever required.
- 9. Regarding list of nine documents to be uploaded for admission to PG Programs along with application form by the candidates, the GRC resolved that Admission Committee of all the Departments must ensure that all mandatory documents required for preparing merit list including weightage are available as all the candidates have been given a final opportunity to edit/update/correct/change/modify in their admission form upto 25.11.2020.
