The Advisory Committee deliberated upon the issue with regard to filling up vacant/leftover seats after 3rd counseling in respect of 4/5/6 years Integrated/ Hons. Programs and made the following recommendations:

1. Position of vacant seats be obtained from the concerned HODs by the Academic Branch after 3rd counseling.
2. Position of vacant seats be displayed on the University Website. Notice be given on University website for filling up the vacant seats after 3rd counseling by seeking option from eligible candidates (who have submitted the online application upto 14.08.2020 i.e. the last date of application submission). No new/fresh application/document will be entertained and considered for the purpose.
3. An applicant as defined above shall exercise option for participating in 4th round of counseling for this purpose. He/she shall inform viva e-mail his/her intent alongwith applicant ID on the following e-mails:
 - i) Concerned HODs/Director of the Department/Institute/Centre.
 - ii) Director, UCC (open.coun@mdu.ac.in) Opportunity for exercising the option shall be available for a period of three days after the third round of counseling where-ever applicable.
4. After receiving the option from the applicants, the Director, UCC will supply the option form/merit list to the various HODs within two days after the last date for verification and finalizing the merit list which would be returned to the Director, UCC by the HODs for displaying on University website within two days. Further Director, UCC will inform the students accordingly for depositing the fee etc.
