Sub: - Admissions in Girls Hostels for the session 2020-21 for Ph. D Students other than Science & Technology.

Sir/Madam,

It is to bring to your kind notice that the hostel accommodation will be provided to the Research Scholars of UTDs (other than Science & Technology with the following conditions:-

- a) All those scholars of UTDs (other than Science and Technology) who are in the **fourth year of registration and old residents of hostels** may be allowed to take admission in hostels till 30.06.2021 or submission of their thesis, whichever is earlier.
- b) The scholar should submit **RT-PCR (COVID-19) negative** test report conducted within 72 hour before the admissions to the hostels.
- c) If a resident after taking admission stays away from the hostel **more than three days**, He/She will have to submit **RT-PCR (COVID-19) negative** test report again, conducted within 72 hour before re-entering the hostel.
- d) The Hostel admission form should be forwarded by the concerned Supervisor & Head/Director of the Department/Institute/Centre along with No Objection certificate from the parents.
- e) The interested Ph. D scholars are required to submit requisite undertakings and an additional proforma in the format attached with the application form (Annexure-A) duly countersigned by respective Supervisor/Guide and HOD/Director of the Department/Institute/Centre for their admission in the University Hostel.
- f) The reservation criteria as per Haryana Government guidelines need to be followed.
- g) Students expelled during the past from M.D.U Hostels are not eligible to apply.

Submission of Admission Form

1. Ph. D Students (other than Science & Technology) admitted in University Teaching Departments should apply filling up Hostel Admission Form. (Attached Herewith)
2. Ph. D Students have also to fill and submit two Undertakings and an additional proforma Annexure-A countersigned by respective Supervisor/Guide and HOD/Director for their admission in the university hostel. (Attached Herewith)
3. Only those Ph. D students are eligible to get admission in University Girls Hostels who have been availing URS or Scholarship/Fellowship from any Central/State Government funding Institutions and whose attendance in the Department is mandatory.

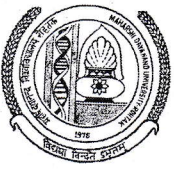
