In view of orders dated 27.06.2021 received vide letter No. DMC-SPO-2020/6864 from the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Govt. of Haryana, Haryana State Disaster Management Authority which are as under:-

“ University campuses are allowed to open for Research Scholars, practical classes in laboratories and remedial classes/Doubt classes by adopting requisite social distancing norms, regular sanitisation and COVID-19 appropriate behavioural norms”.

The Committee deliberated upon the matter at length and recommended that the University be opened for Research Scholars, practical classes in laboratories and remedial classes/Doubt classes as under:-

1.	Ph.D Students who require to enter the campus to access the Departments/laboratories will be allowed for experiment work/Research guidance in consultation with Supervisor and permission from the concerned Head/Director.
2.	For practical classes in the Laboratories remedial classes/doubt classes in case of students of Even Semester (except PG 2 nd semester) with immediate effect . Doubt classes shall be held in groups once a week for each class. The group shall be formed by the concerned HOD as per need.
3.	For practical classes in the laboratories, examinations and remedial classes/doubt classes in case of PG Programs (2 nd semester) w.e.f. 05.08.2021 .
4.	Central Library will be opened for research scholars and faculty members for reading purpose. All other students will be allowed for the purpose of return and issue of books only. (From 9:00 A.M. to 5:00 P.M. on working days) .
5.	Hostels (Boys/Girls) will also be opened from 05.07.2021 for the students as mentioned at Sr. No. 1 & 2. For Sr. No. 3, the hostels shall be opened from 05.08.2021 . Chief Warden (Boys/Girls) may make necessary arrangements and sanitization of Hostels and ensure implementation of the guidelines/instructions for the students in view of the general hostel rules and COVID-19 pandemic norms.
6.	The HODs/Directors/Chief Wardens are requested to follow the SOPs/Guidelines issued by DMC/MHRD/MDU from time to time. The HODs be also requested to ensure that the students are called in batches/groups ensuring SOPs issued by MHA/SDMA from time to time including norms of social distancing and COVID appropriate behaviour.
