





I am directed to invite your attention to Government notification issued vide No. 7/28/2021-2GS-II, dated 8th June, 2021 (copy enclosed) and to say that State Government has decided to grant Special Compassionate Financial Assistance to the eligible family member(s) of an employee working on regular basis or adhoc, temporary, work charged, daily wages, honorarium based, Guest Teacher, engaged under Outsourcing Policy Part I and Part II who dies while on active Covid Duty, especially related to management of Covid or maintenance of essential services or dies due to Covid disease, as per provisions contained in the notification enclosed herewith.



NOTIFICATION

Subject : Awarding Special ex-gratia grant /Special Compassionate Financial Assistance to the families of Corona Warriors and employees who expire due to Covid disease.

Covid-19 is a State Disaster as per Section 2(d) of Disaster Management Act, 2005 and the State Government has mobilised the entire State machinery and resources at its disposal to combat the situation arising due to the outbreak of Covid-19. A large number of Covid Warriors comprising regular employees, ad hoc, temporary, work charged, daily wages, honorarium based and persons engaged under Outsourcing Policy Part I and Part II are working day and night risking their lives to provide urgent medical treatment and other support services to the affected population and to enforce restrictions to ensure the containment of the pandemic.

2. The Governor of Haryana in exercise of power conferred under Article 309 of the Constitution of India is pleased to provide a safety net to the families of employees as Special Compassionate Financial Assistance as under :-

- (1) **In case of death of Corona Warriors on Covid Duty:** In case of death of an employee working on regular basis or ad hoc, temporary, work charged, daily wages, honorarium based, Guest Teacher, engaged under Outsourcing Policy Part I and Part II while on active Covid Duty, especially related to management of Covid or maintenance of essential services, the eligible family member(s) shall be paid Special Compassionate Financial Assistance of Rs. 20.00 lakh, posthumously.
- (2) **In case of death of employees due to Corona disease:**
 - (i) In case of death of a Government employee working on regular basis in any Department of Haryana Government by contracting the Covid disease, his/her family shall be paid a Special Compassionate Financial Assistance of Rs. 5.00 lakh, posthumously.
 - (ii) In case of death of a person while working on ad hoc, temporary, work charged, daily wages, honorarium based, Guest Teacher, engaged under Outsourcing Policy Part I and Part II occurs due to Covid

- disease, his/her family shall be paid Special Compassionate Financial Assistance of Rs. 5.00 lakh, posthumously in place of Compassionate Financial Assistance of Rs. 3.00 lakh admissible under GAD's instructions dated 27.11.2014/28.07.2016.
- (3) The Special Compassionate Financial Assistance of Rs. 20 lakh admissible under para 2(1) above or Rs. 5 lakh under para 2 (2)(i) above admissible to the families of deceased employees working on regular basis shall be in addition to the benefit admissible under Ex-gratia Policy, 2019 notified vide No. G.S.R.32/Const./Art. 309/2019, dated 2nd August, 2019.
 - (4) The definition of 'Family' for the purpose of Special Compassionate Financial Assistance shall be the same as defined in Ex-gratia Policy, 2019.
 - (5) If any financial assistance or grant is admissible to the family of deceased Corona Warrior or employee under Covid-19 related any other Scheme of a Department/Board/Corporation of any State Govt. or Govt. of India, then the amount of Special Compassionate Assistance admissible under this notification shall be reduced to that extent.
 - (6) The family of deceased employee/person shall submit an application in the prescribed form, as at Annexure-A, alongwith the death certificate, copy of report of Death Audit Committee of concerned Hospital/Medical Institution chaired by the Civil Surgeon of the District alongwith other documents to the concerned Head of Office which will be examined by him and forwarded to the Head of Department for further necessary action.
 - (7) The application(s) received in the office of Head of Department shall also be examined by them before forwarding the same to the Administrative Department concerned. Thereafter the matter shall be referred to the Finance Department by the Administrative Secretary with their recommendations.
 - (8) After the approval of Finance Department, the sanction shall be issued by the Administrative Secretary concerned. The payment of Special Compassionate Financial Assistance may be made by the concerned Head of Office/D.D.O. from the Haryana Covid Relief Fund (HCRF) or State Sources.
 - (9) This notification shall be applicable w.e.f. 1st March, 2021 and cases prior to this date shall not be opened. The concurrence of Finance Department has been obtained vide UO No. 5/19/2021-5FR/217240, dated 4th June, 2021.
