*B.A., B.Ed, B.Sc. B.Ed. and B.El.Ed. obtaining not less than 50% marks in the aggregate(47.5% in the case of SC/ST/Blind/visually and Differently Abled Candidates of Haryana only)

RESOLVED THAT THE ELIGIBILITY CONDITIONS FOR ADMISSION TO M.ED PROGRAM AS ABOVE BE RECOMMENDED TO THE ACADEMIC COUNCIL FOR APPROVAL.
