Sir/Madam,

I am directed to inform you that various Colleges/ Institutes which have been transferred in other Universities of Haryana since the session 2017-18 approach to this University regarding admission of gap year students which were registered with this University.

In this connection, it is clarified here that as per University Ordinance: a candidate can complete his/her degree within maximum period of Course+3 years.

Therefore, a candidate who has gap in studies can be granted admission after he/she submits an undertaking describing the reason of the gap period and also that he/she has not indulged in any illegal activities, keeping in view the maximum duration to complete the course. The concerned College/Institute needs to complete the Continuation Return process of the gap year students as per schedule of RR/CR issued by the University for the session 2021-22.

However, if any college is unable to give admission to the students due to any valid reason or the student wants to take admission in any other college under this University as on date. In such type of cases, the College/Institute may forward the case to this office for shifting of the student to the desired college/Institute affiliated with M.D. University, Rohtak alongwith NOC or consent letter from the College/Institute in which the student wants to be shifted. There would obviously be no requirement of Migration Certificates, being already registered with the University.

You are therefore, requested to forward the application of the gap year students who were registered with this University for maintaining the data of the student on the CR portal with the necessary details of the student i.e. Student No., Registration No., Student Name, Father's Name, Date of Birth, Semester, Course and a copy of previous semester result copy of the student so that such types of students may be added to the CR portal for CR process.
