MINUTES OF THE MEETING OF THE GRIEVANCE REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 29.03.2022 AT 11.00 AM IN THE COMMITTEE ROOM, ADJACENT TO THE REGISTRAR OFFICE, M.D.UNIVERSITY, ROHTAK TO CONSIDER THE VARIOUS REQUESTS RELATING TO ADMISSION TO PH.D. PROGRAM AND AWARD OF URS FOR THE SESSION 2021-22.

The Committee deliberated upon various issues relating to admission to Ph.D. Program and Award of URS for the session 2021-22 and resolved as under:-

1. Considered the request of Ms. Kusha Sharma for grant of supernumerary seat for admission to Ph.D Program 2021-22 in the Department of Education, MDU, Rohtak.
RESOLVED THAT THE HEAD, DEPARTMENT OF EDUCATION SHALL PROVIDE ALL THE RELEVANT DOCUMENTS VIZ., ONLINE APPLICATION FORM, ENTRANCE TEST DETAILS, NOC FROM EMPLOYER SO THAT THE CASE MAY BE EXAMINED BY THE GRC ACCORDINGLY.
2. To note the action taken w.r.t. two admissions made in the Ph.D. Program in the session 2021-22 in the Department of Physics by taking consent of the supervisor Dr. Manju, Assistant Professor (Physics) in UIET.

RESOLVED THAT THE COUNSELLING FOR AWARD OF URS FOR THE SESSION 2021-22 AGAINST VACANT SEATS BE CONDUCTED BY CONCERNED DEPARTMENTS WITHIN A WEEK OF THE ISSUANCE OF THE MINUTES OF GRC FOR AWARD OF URS FOR THE SESSION 2021-22.
FURTHER RESOLVED THAT ALL THE STUDENTS WHO HAVE BEEN AWARDED THE URS IN THE SESSION 2021-22 BUT COULD NOT APPLY FOR THE SAME THROUGH MDU ONLINE PORTAL EARLIER, THEY SHALL PAY THE APPLICATION FEE OF RS. 300/- THROUGH UNIVERSITY CASH RECEIPT AND THE HEAD/DIRECTOR CONCERNED SHALL ENSURE THE SAME.


