**IMPLEMENTATION OF FOOD SAFETY AND STANDARDS ACT, 2006**

All the eateries operating from the university campus, including the facilities that are being operated by the institution itself are required to follow the provisions of the Food Safety and Standards Act 2006. Any such eating joint that is found to be preparing and selling any eatable or beverage in contravention with the provisions of the Act or in adulterated form or selling stale food or fruits shall evoke the penal provisions specified in the Act and would thus be dealt with sternly, while facing action as per the penal provisions of the referred Act. These shall also remain applicable on the Faculty House, all university canteens, all the cooperative or otherwise functional messes of all the girls' and boys' hostels and over the Institute of Hotel and Tourism Management, M.D. University, Rohtak.

The university expects each and every one to take utmost care of the health and safety of the customers as well as their own personnel in consonance with the provisions of the Act and maintain the highest standards in preparation and serving of the eatables and beverages etc. The cooperation of all our valuable partners, functionaries and operators is solicited in letter and in spirit.
