According to Dr Sarkar, who is also the president of Indian Association of Dermatologists, Venereologists and Leprologists, topical steroids provide instant relief to inflammation but in the long run, they tend to damage the skin and leave it vulnerable to opportunistic infections.

Other side-effects caused by topical steroids include necrohemorrhages into the skin, dilated blood vessels, visible veins and excessive hair growth.

"A patient should stop using any cream that is causing excessive redness and visible vessels on the skin. It is a sure case of steroid abuse," said Dr Kabir Sardana, professor of dermatology, Ram Manohar Lohia hospital.

He added many people use over-the-counter fairness creams that contain steroids. Some of these also contain potential allergens, particularly fragrance allergens.

"Fairness creams can occlude pores, leading to break of acne, and contain potential allergens, most common fragrances. Those that contain topical steroids can thin a person's skin, increase redness and make blood vessels visible," warned Dr Sarkar.

She added: "One of my patients had dark pigmentation on face and was given a cream by the local pharmacist. Sadly, no one monitored her. Though initially there was improvement, it started getting darker. Her chemist eventually told her that her skin has become resistant and advised her to apply it more frequently. She showed up at our doorstep with severe darkening and raised areas of skin. I prescribed sunscreen and asked her to stop all other applications, after which she improved."

In another case, a 27-year-old girl used clobetasol, a potent topical steroid, twice daily for weeks to look fair. Dr Sarkar said, "Whenever she stopped using the cream, her face got red and warm. We had to reduce the dependence on it to salvage the damage," Dr Sarkar said.

Should be named 'Kejriwal-phobia' Bill, says AAP MP

New Delhi: During the debate on the MCD reunification bill which was passed by the Rajya Sabha on Tuesday, AAP's Jay Singh said it should be renamed as "Kejriwal-phobia" as it was meant to prevent AAP from coming to power. Congress's Abhishek Manu Singhvi termed it as "constitutionally suspect, legally untenable, administratively blunder and politically hypocritical".

YSR Congress, AIADMK, Tamil Maanila Congress supported the bill. Union home minister Amit Shah rebuffed the charges, saying that the splintering of the MCDs was arbitrary and effected in a haphazard way, and accused the Kejriwal government of pursuing a "step-motherly" approach towards the three BJP-governed corporations so that they get discredited in the public eye and AAP gets to control the municipal bodies.

"You have a problem with BJP but you took it out on people of Delhi by neither giving them funds, nor allowing them to raise resources on their own. Do you think people cannot see through this? We are going to take this to the people," said Shah, sketching what could possibly be BJP's campaign plank in the polls.
