Sub.: Instructions regarding COVID-19 - Closure of University

Sir/Madam

I am directed to inform you that a meeting of the committee constituted by the Vice-Chancellor was held on 03.01.2022 at 11:00 am in the Committee Room of Registrar Office to consider the matter regarding instructions received from the State Government vide memo no. E-565431 DHE-010009/1/2022-Coordination-DHE dated 02.01.2022 on the subject cited above. The Committee recommended the following which have been approved by the Vice-Chancellor:-

1. Instructions issued by the State Government vide memo no. E-565431 DHE-010009/1/2022-Coordination-DHE dated 02.01.2022 be complied with by all concerned.
2. A letter be written to the DGHE, Panchkula, Haryana for seeking permission for continuation of already going on examinations of special /mercy chance examinations in the Campus.
3. The University library be closed. However, issue/return of books be allowed during 9:00 am to 5:00 PM by following the COVID-19 appropriate behavior.
4. Contact games in the Sport Complex of M.D. University, Rohtak be not allowed upto 12th January, 2022 in view of the instructions of the State Government.
5. In view of situations arising due to COVID-19 Pandemic, the criteria for award of internal assessment for UG/PG and Ph.D. Programs except Pharmacy and Engineering courses for the session 2021-22 will comprise two assignments (10 marks each) only for odd semesters.
6. In view of COVID-19 Pandemic, the students of 3rd semester of PG Programs be allowed to offer Review Writing in place of Dissertation, wherever prescribed in the relevant scheme of examinations, for the session 2021-22 only.
