Candidate ineligible for quota can be considered in open category: HC

CHANDIGARH, MAY 31
 The Punjab and Haryana High Court has described as preposterous the state of Haryana's arguments that a candidate found ineligible for reservation in a selection process would not be considered even in the open or the general category. The Bench made it clear that the same went against the "very content and intent" of Article 16 of the Constitution.

"No doubt, reservation is envisaged on the basis of backward class under Sub Article (4). But in case a candidate is not found, or found, entitled to the reservation, by no stretch of imagination Article 16 is to be interpreted so as to mean that right of a candidate to be considered in open general category is taken away if that were to be done, same would be also violative of Article 14 of the Constitution of India, apart from Article 16(1) itself," Justice Anil Monga ruled.

In his detailed order, Justice Monga asked the Haryana Staff Selection Commission and others respondents to be aware of, and careful, in future about the basic principles of reservation. The first and foremost was that the general category seats were to be filled from the merit list in accordance with the result. Thereafter, the reserved category seats were to be allocated in accordance with the quota assigned thereto.

Justice Monga was hearing a petition filed by Om Raj against the HSSC and other respondents for the issuance of directions to consider his claim for selection and appointment as veterinary livestock development assistant against the general category as he had obtained higher marks than the last selected candidate in the general category. Even if he was not given the benefit of the EWS reservation, he was eligible to be considered in the general category as he had obtained more marks than the last selected candidate.

"It is rather preposterous to argue, as is being canvassed by the state counsel, that if in the scrutiny round a candidate is found not eligible for the reservation sought by him, he shall not be considered even in the open (general) category," Justice Monga asserted, while holding the petitioner entitled to consideration in the general category.

Referring to the procedure, Justice Monga asserted that a candidate considered ineligible in the reserved category after applying under it, had a right to select and appointment under the general category. This was in case he had obtained higher marks than the last selected candidate in the general category.

Setia polygraph test in Gujarat

GUJARAT, MAY 31
 A local court today ordered the polygraph test of suspended IPS officer Dinesh Setia in Gujarat.

The special task force (STF) had sought it outside the NCR, suspecting Setia could influence the test result. The STF will now proceed to get in touch with Gujarat's Gandhinagar laboratory to get the test done.

The next hearing in the case will be on June 13 and the STF has been asked to have to get the test done before that date.

The guidelines of the Supreme Court will have to be followed during the test. During the hearing in the court of the Additional District Sessions Judge Tarun Singh on Tuesday a decision was taken in which, till the polygraph test would be done.

Setia was not present during the hearing in the court, pleading illness.

Meanwhile, the STF produced another accused, Chetan Man, alias Bawa, after seven-day police remand in court, from where he was sent to judicial custody. The STF claimed to have recovered an SUV and Rs 1,900 from his possession.

According to public prosecutor, Jagbir Chawla, accused Setia did not appear in the court today but through his counsel Setia appeared for the polygraph test. Setia requested a polygraph test be conducted in the Delhi NCR while he resided on a location like Hyderabad and Ahmedabad, added advocate Chawla.

Setia is out on bail from the High Court. In August 2021, one of the accused Dr Sachdev Jan Nawal was arrested in the multi-crore heist, who had accused Setia of taking bribe of crores to cover up the case. At this, the STF had made the IPS officer an accused and the state government had suspended Setia.

A senior STF officer said till today, 16 accused had been arrested in connection with multi-crore heist.

Chawla's hearing has been filed against 14, including one key accused Dr Sachdev Jan Nawal.

Attacking CM, Rohtak MP trains guns on Hooda

ROHTAK, MAY 31
 Having met Chief Minister Manohar Lal Khattar and his party in the dock over the Pehrawar land row, BJP MP from Rohtak Arvind Sharma today launched a scathing attack on former CM Bhupinder Singh Hooda and his son Deepender Hooda.

While interacting with media persons here today, Sharma accused the father-son duo of dividing society on caste lines and promoting corruption during the Congress regime from 2005 to 2014. They (Hoodas) were again preparing to grab power, but they would not succeed in their intention as the people know what had happened during the Congress regime. So, the people would not support the Hoodas in any condition, he claimed.

Responding to a question on Pehrawar land row, Sharma said, "I do not want any credit in connection with the row. But I want that the state government should give the land back to Gaur Brahmin Society at the earliest. It should even chalk out a development plan to set up educational and health institutes over the land."

Sharma had recently accused Khattar of violating the Constitutional oath taken by him at the time of his swearing in. Referring to the Pehrawar land row, he said, "The oath specifically mentions that the Chief Minister will not have antipathy towards any section of society, but he has violated that oath. The Prime Minister's Office should take cognizance of the matter, get it looked into and take action."

Sharma said the CM was purposely delaying the handing over of a chunk of nearly 15 acres in Pehrawar village of Rohtak to the Gaur Brahmin Education Society.
