Govt approves mapping of land for AIIMS, letter of intent issued

In a significant development, the state government has approved the map for the proposed land in Majra village for the AIIMS project.

The Department of Medical Education and Research has also sent a letter of intent to the district authorities for issuing it to the landowners so that the process of buying the land could be initiated.

The government has assured villagers of buying their land at Rs 40 lakh per acre. Sources said the final map was sent to the state government two weeks ago after making necessary changes as per the technical parameters of the project and availability of land.

Chief Minister Manohar Lal Khattar had announced the project in Bawal town in 2015, but it could not be materialised owing to a matter pertaining to the Centre. This freed the State Government from the AIIMS Sangharsh Samiti to stage a dharna for 127 days to pressurise the government for executing the project.

Later in 2019, just before Lok Sabha polls, Prime Minister Narendra Modi announced to set up AIIMS here.

Deputy Commissioner Ashok Gupta said the registration of sale deed of proposed land would be started along with the issuing the letter of intent to landowners.

"landowners will be informed 48 hours in advance to complete the registration process at the tehsil," he said.

Meanwhile, Rajendra Nimoth of the AIIMS Sangharsh Samiti said it was claimed that the process to buy the land would be initiated in May, but nothing was done.

"There is no need for a letter of intent when the villagers have already proposed AIIMS project by uploading land details at the e-bhumi portal. The government should initiate the process if its intention towards the project is honest," he added.

ARRANGEMENTS FOR REGISTRY IN PLACE

All arrangements for the registry of the land have been made at the tehsil so that landowners do not have to face inconvenience.

2 get life term for murder

SONPAT, JUNE 2

The court of Additional District and Sessions Judge Devinder Singh today awarded rigorous imprisonment for life to two persons for murdering a labourer.

The incident was reported to the Kharakhoda police on October 3, 2019. Gyandev Prasad of Bihar-said his elder brother Dharmender (40) was working as a labourer in the fields of a farmer Yashveer of Siana.

Dharmender was found unconscious in the fields on October 1, 2019.

Yashveer had taken him to the CHC, Kharakhoda, where doctors declared him dead. Later, it was disclosed in the postmortem report that Dharmender was beaten to death. The police also suspected Yashveer of murdering him.

Following his complaint, the Kharakhoda police registered a case against Yashveer and arrested him. During investigation, it was revealed that Yashveer, Dharmender and Yashveer's friend Mohit, Ankita, alias Sonu, of Chhokla village drank together and after that, Yashveer and Mohit beat Dharmender badly.

Agri Dept targets 1 lakh acre to reduce paddy cultivation

In order to promote crop diversification and reduce the area under water-guzzling paddy crop, the Department of Agriculture and Farmer Welfare will target 1 lakh acre land in the kharif season 2022 under the "Mera Pani, Meri Virasat" scheme.

To achieve the target, the department has also set district and crop specific targets.

The department is aiming to sow maize in 15,000 acre, cotton in 51,500 acre, pulses in 2,500 acre, oilseeds in 1,000 acre, fodder/fallow in 15,000 acre, and vegetables in 15,000 acre across the state.

The largest share of the target land will be in Sirsa district (13,775 acre), followed by Jind (11,655 acre) Fatehabad (10,796 acre), Kaithal (7,338 acre), and Hisar (7,088 acre) districts.

Last year, the department had planned to cover 2 lakh acre but registrations of around 98,000 acre land was received. After verification, the department could achieve crop diversification only on 53,000 acre. Learning the experiences of the previous year, the department had decided to set realistic mark this year.

Each crop has been allotted a specific target for each district, according to the different agro-climatic conditions. However, the district will also get additional budget if it exceeds the given target.

Like previous years, the farmers will be given an incentive of Rs 7,000 per acre if they opt for crop diversification. Unlike last year when the incentive was given in two instalments, this year the incentive will be given in one instalment after physical verification by a committee, consisting the department official, farmer, numberdar and the patti concerned.

The benefits of the scheme will be extended to farmers who had cultivated paddy last year and want to opt for alternative crops, and those who had adopted crop diversification last year and will continue with alternate crops on the same field. The farmers who will keep their last year's kharif paddy fields fallow during the season are also eligible for the incentive.

Director General of the Agriculture and Farmers Welfare Department, Hardeep Singh, said: "Farmers have to get themselves registered, following which the department will get the details of the crop sown last year. Verification by village-level committee will be done. Once, the process is completed the farmer will be compensated for adopting alternative crops."
