Sir,

I have been directed to inform you that the State Govt. vide Notification dated 15.2.2019 decided that all the colleges situated in Gurugram and Nuh/Mewat districts will remain under the territorial jurisdiction of Gurugram University. Aggrieved from the decision of the State Govt, your college filed a case in the Hon'ble High Court at Chandigarh and also obtained interim stay order on the said State Govt. Notification. Accordingly, affiliation of the Dronacharya College of Engineering, Gurugram remained continue with M.D.University subject to final outcome of the Court case.

Now, the Hon'ble High Court passed order on 25.2.2022 that "In view of the averments made in the application, the main case is dismissed as withdrawn (copy enclosed)". Therefore, presently the territorial jurisdiction of your college falls under the

Gurugram University, Gurugram.

You are, therefore, requested to take up your case(s) with the Gurugram University, Gurugram with immediate effect for taking further necessary action, being the present affiliating University as already decided by the State Govt.
