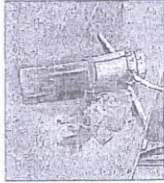
# Man detained for 'aiding' Mohali intel HQ attackers

**CHANDIGARH/MOHALI:** A man from Tarn Taran district has been detained in connection with the explosion at the Punjab Police's intelligence wing headquarters in Mohali, people familiar with the developments said on Wednesday.

Jagrup Singh, a resident of Mehindipur village in the Khambhat Sahib region of the district, was detained after the investigating team got a strong lead about the role of some suspects in providing logistical help and arranging stay for the attackers, a senior police officer part of the probing team said, asking not to be named.

Singh was lodged in Faridkot jail on murder charges and had

have recovered the rocket launcher used in the RPG attack. The Russian-made launcher was found in bushes around 10m from the intelligence headquarters, an

different case of smuggling of weapons.

Faridkot police have found no link of Nishan with the Mohali blast. Neither any higher authority nor agency has sought his custody from us so far," superintendent of police (detective) Faridkot, Bal Krishna Singla said, adding that Nishan has been sent to five-day police remand.

Earlier, the police said they have already rounded up several suspects for questioning.

On Wednesday, a CCTV footage of the RPG attack on the building Mohali's Sector 77 also emerged, one of the people cited above said.

In the footage, a car was seen moving on the road in front of the intelligence headquarters build-

ings in Punjab and Maharashtra, before he fled to Pakistan two years ago.

Senior police officials said preliminary probe suggested the attack was executed by members of a local gang active in Punjab and Haryana, at the behest of Pinda.

Soon after the attack, Punjab chief minister Bhagwant Mann promised strictest punishment to those trying to spoil the state's atmosphere. Mann, who held a meeting with the director general of police and other senior officials on Tuesday, said nobody would be allowed to disturb the peaceful atmosphere of Punjab.

## TRIBAL WOMAN RAPED, KILLED IN T'GANA: POLICE

**HYDERABAD:** Telangana police arrested a 25-year-old man on Wednesday for allegedly raping and murdering a 23-year-old tribal woman in the Yadadri Bhongir district, about 40 km from Hyderabad, officials said.

According to police, the incident occurred on Monday evening in Toopranpet village of Chouppal block in the district. "We produced him before the local court in the afternoon, and he was sent to judicial custody for 14 days," Choutupal assistant commissioner of police (ACP) M Uday Reddy told HT.

The accused, who hails from the Zabaretabad area of Sangareddy district, is booked under sections 376 (rape), 392 (robbery) and 302 (murder) of the Indian Penal Code (IPC), besides the SCST (Prevention of Atrocities) Act, police said.

The autopsy revealed that she was raped twice and had sustained grievous injuries on

# J'khand's mining secy arrested in PMLA case

**RANCHI:** The Enforcement Directorate (ED) on Wednesday arrested Jharkhand mining secretary Pooja Singhal in connection with a money laundering case linked to alleged embezzlement of MGNREGA funds in Khunti district of the state and other charges, officials familiar with the case said.

The 2000-batch IAS officer was produced before the court of FK Sharma, designated to hear money laundering cases in Ranchi.

"We pleaded before the court for 12 days remand but the court has granted five days remand. Today she would remain in jail. The agency would begin further questioning from the officer Thursday morning," Singh, special public prosecutor, the agency said.

The federal agency had ques-

tioned the scanner in the case, for around nine hours on Tuesday. The duo were called for questioning again on Wednesday.

The agency conducted raids at various locations across four states in connection with the case on May 6 and recovered ₹17.49 crore from the residence of Suman Kumar, a chartered accountant associated with Singhal.

The ED investigation pertains to a money laundering case in which

by the agency on June 17, 2020 from West Bengal after he was booked by the agency under the PMLA in 2012 based on FIRs of the state vigilance bureau against him.

Singha was booked by the state vigilance bureau under criminal sections of the Indian Penal Code (IPC) pertaining to cheating and corruption for allegedly defrauding public money and investing it in his own name as well as in the name of his family members while working as junior engineer from April 1, 2008 to March 2, 2011.

As per ED, the said money was earmarked for the execution of government projects under the Mahatma Gandhi National Rural Employment Guarantee Act in Khunti. Singhal also served as deputy commissioner of the district between 2009 and 2010.

ED claimed that during the period charges of "irregularities"

## Apex court puts sedition law on hold

Says it expects Centre, states not to file fresh cases under Section 124A till review

NEW DELHI, MAY 11 In a historic order, the Supreme Court on Wednesday put on hold the sedition law as it asked the Centre and

passed these orders in a petition taken up suo moto by the petitioner as a public interest litigation on a letter addressed to the Chief Justice by one Pratap Singh Thakur of Bagshad village, Karnal district.

In the petition, it was alleged that more than 2,000 posts of Junior Office Assistant and Librarian are lying vacant in the government schools across the state and the Education Department is not filling the posts deliberately so that the children of government schools join private schools to pursue their studies.

He has further alleged that due to lack of library and librarian in government schools, children are lagging behind in competitive examinations. As such, children are leaving government schools and opting for private schools.

The petitioner has sought the court to direct the state government to fill the vacant posts of librarians in the government schools on priority.
