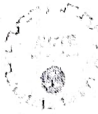

CLEC is registered as a non-profit professional educational institution for international Chinese language education, affiliated with the Ministry of Education of People's Republic of China.

Any collaboration with any NGO / Foundation is subject to Foreign Contribution (Regulation) Act (FCRA). Hence, all Universities / Institutions having collaboration with Confucius Institutes/Hanban/CLEC or planning to collaborate to set up Confucius Institutes (CIs) or any other joint venture in any other name will be required to seek prior clearance under FCRA.

Further, as per extant policy, CIs are regarded as Foreign Cultural Centres and require the approval of Ministry of External Affairs for setting up / continuation / renewal of such centres.
