Notes:

1. For UTDs, the Students who want to freeze their seat will be required to deposit full fee online.
2. For UTDs, the students who opt for holding the seat and participate in next round of counselling shall submit fee in the form of DD of Rs. 5000/- in favour of Finance Officer, MDU, Rohtak Payable at Rohtak and submit the same in the concerned department. The students can also submits token amount through online SBI collect (link available at the university website) and the submit the receipt to the concerned department
3. For colleges the college shall adopt the process of full fee collection if the student desires to freeze the seat for token money of Rs. 5000/- if the student desires to participate in the next round of counselling as per their own mechanism keeping in the view the refund provision of the fee as per the clause 11 (Page no. 9, section-I) of the prospectus.
