Sir/Madam,

I am directed to inform you that on the recommendations of Admission Sub-Committee in its meeting held on 04.08.2023, the Vice-Chancellor has approved the following:-

1. That in supersession of the letter bearing no. AC-I/Adm.23/15550-60 dated 25.07.2023 (copy enclosed), the rider of minimum cut off of 50 marks in entrance test be removed for the admissions against Supernumerary seats of the candidates belonging to States other than Haryana and who had applied in All India Open Category.
2. That in the UTDs/ Institutes where all applications for admissions are exhausted and seats still remain vacant on 7<sup>th</sup> August 2023. The fresh online applications will be invited for such vacant seats in all such Departments/ Institutes. All such Departments/ Institutes should provide the status of vacant seats by 9<sup>th</sup> August, 2023 to the Academic Branch so that the process of inviting fresh applications be initiated. Such Admissions will be made as per Academic Merit of qualifying examination. The schedule of admission in case of fresh online applications will be as under:

Sir/Madam,


I am directed to invite your kind attention towards the following clarification / information.

- 1) Counselling of supernumerary seats will be held on 26.7.2023 for 3-Year, 4-Year, 5-Year Integrated programmes and on 07.08.2023 for all P.G.Programmes (2 Years) and B.P.Ed Programmes.
- 2) As per decision of the Univeristy 10% supernumerary seats in all programs except those which are governed by regulatory bodies as AICTE/PCI/ BCI etc. have been created for the applicants belonging to States/UTs other than Haryana. These over and above supernumerary seats will be filled as per merit in entrance examination from the applicants belonging to States/UTs other than Haryana who applied in All India Open Category, provided that such applicants secure minimum 50% marks in their Entrance Examination.

The counselling for these seats will be held on 26.07.2023 in case of 3 Year, 4 Year and 5 Year Integrated Programmes and on 07.08.2023 for all 2 Year PG and B.P.Ed. Programs.

All HODs / Directors are requested to make admissions accordingly as per merit after verifying the claim of the candidates by supporting documents.
