- The author shall submit an abstract of not more than 300 words with a cover letter containing the name(s) of the author(s) and address, designation, institution/affiliation, the title of the manuscript, theme, and contact information (email, phone, etc.).
- The authors of final selected manuscripts will be called for Paper Presentation.
- For Paper Presentation, the Paper submission must be made to seminarlaw23@gmail.com
- Maximum Co-authorship of two (2) is permitted.
- The manuscript should be on A4-sized paper in MS Word format and conform to the following guidelines.
- The research paper structure shall be in
 - Font: Times New Roman,
 - Size: 12,
 - Line spacing: 1.5
 - Margin: of 2.54 cm on all sides
- Footnotes should be:-
 - Times New Roman,
 - Size 10
 - Line Spacing - 1.0
- Texts and footnotes should conform to the Journal of the Indian Law Institute (JLI) citation format.
- Word Limit: 3000-5000 words
- The submission must be the original work of the authors.
- Any form of plagiarism will lead to direct rejection.
