**MINUTES OF THE MEETING OF THE COMMITTEE OF THE GRIEVANCE REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 14.12.2022 AT 03.00 PM IN THE COMMITTEE ROOM, ADJACENT TO REGISTRAR'S OFFICE, M.D.UNIVERSITY, ROHTAK TO CONSIDER VARIOUS ISSUES RELATED TO DIPLOMA/PH.D. ADMISSIONS ETC.**

The Committee considered the various issues and made its recommendations as under:-

1. Considered the representation dated 12.12.2022 of Dr. Vikas, UIET for reconsideration of the decision made by the GRC held on 21.11.2022 under Resolution No. 1 w.r.t. the case of Ms. Bhawna Dangi.

**THE COMMITTEE RECONSIDERED THE MATTER IN VIEW OF THE LATEST FACTS PRESENTED BY DR. VIKAS AND THE DIRECTOR (UIET) BEFORE THE GRC COMMITTEE AND RESOLVED THAT THE DECISION TAKEN BY THE GRC UNDER RESOLUTION NUMBER 1 OF ITS MEETING HELD ON 21.11.2022 BE REVISITED AND THE DIRECTOR (UIET) MAY TAKE ACTION AS PER APPLICABLE PH.D. ORDINANCE.**

2. Considered the various representations received from various students/teachers of 'Direct JRF category' for not allowing them to take admission in Ph.D. Program by the Departments/ Institutes due to lack of clarification in the clause -12 of Ph.D. Ordinance relating to Number of Research Scholars to be enrolled by a Supervisor.

**RESOLVED THAT ALL SUCH APPLICATIONS OF THE APPLICANTS BE FORWARDED TO THE CONCERNED HEAD/DIRECTOR OF THE DEPARTMENT/INSTITUTE TO TAKE ACTION AS PER PH.D. ORDINANCE WITH THE FOLLOWING CLARIFICATION:**

**(A) TWO EXTRA SEATS MEANT FOR ADMITTING DIRECT JRF STUDENTS/SUPERNUMERARY CATEGORY ARE OVER AND ABOVE THE MAXIMUM NUMBER OF SEATS AVAILABLE UNDER A SUPERVISOR. I.E. 8+2 FOR PROFESSOR, 6+2 FOR ASSOCIATE PROFESSOR AND 4+2 FOR ASSISTANT PROFESSOR. HOWEVER, THE ADMISSION AGAINST THESE TWO SEATS CAN BE TAKEN ONLY UNDER THE ELIGIBLE TEACHERS OF UNIVERSITY TEACHING DEPARTMENTS AND MDU-CPAS, GURUGRAM.**

**(B) DIRECT JRF CATEGORY STUDENTS CAN ALSO TAKE ADMISSION UNDER THE ELIGIBLE TEACHERS OF AFFILIATED COLLEGES/INSTITUTES UNDER THE MAXIMUM LIMIT AVAILABLE UNDER CLAUSE-12 OF THE PH.D. ORDINANCE. THE ELIGIBILITY OF THE SUPERVISOR SHALL BE AS PER PROVISIONS OF THE PH.D. ORDINANCE.**

Considered the request of Incharge (MDU-CPAS), Gurugram for allowing him to take admissions of the applicants in the Diploma in Cyber Law and Diploma in Labour Law & Social Welfare so that the condition of minimum strength to run the Diploma Program may be fulfilled and the interested candidates may take admission.

**RESOLVED THAT THE INCHARGE (MDU-CPAS), GURUGRAM MAY BE ALLOWED TO MAKE ADMISSIONS AT ITS OWN LEVEL WITHIN A WEEK OF THE ISSUANCE OF GRC MINUTES BY CONDUCTING PHYSICAL COUNSELLING AND SUBMISSION OF FEE BY THE CANDIDATES. THE REGISTRATION RETURN OF SUCH APPLICANTS BE SENT BY THE INCHARGE (MDU-CPAS), GURUGRAM WITHIN 10 DAYS OF MAKING THE ADMISSIONS. IF THE CONDITION OF MINIMUM NUMBER OF STUDENTS IS NOT FULFILLED, THE INCHARGE (MDU-CPAS), GURUGRAM SHALL TAKE ACTION FOR REFUNDED OF FEE OF THE ADMITTED STUDENTS AS PER EXISTING PROVISIONS OF THE UNIVERSITY.**

4. Considered the request received from the Head, Department of English & Foreign Languages, for shifting of the students from Certificate course in Spanish to Certificate course in French/German as the condition of minimum number of students in the Certificate Program in Spanish is not fulfilled.

**RESOLVED THAT THE REQUEST OF HEAD, DEPARTMENT OF ENGLISH & FOREIGN LANGUAGE BE ACCEDED TO. THE HEAD OF THE DEPARTMENT MAY SEEK OPTION FROM THE STUDENTS FOR SHIFTING TO OTHER CERTIFICATE PROGRAM I.E. CERTIFICATE COURSE IN FRENCH OR CERTIFICATE COURSE IN GERMAN. THE HEAD MAY INVITE OPTIONS AT ITS OWN LEVEL AND SHIFT THE STUDENTS WITHIN A WEEK OF THE ISSUANCE OF THE MINUTES OF THE GRC.**

5. Considered the representation received from Teachers Associations of the Colleges for making provision of Supernumerary seat for teachers of affiliated Colleges/Institutes at par with provision for University appointed teachers under the Ph.D. Ordinance.


