AS PER HARYANA GOVT. GAZETTE NOTIFICATION DATED 15.05.2020 AND AS PER LISTS NOTIFIED BY THE STATE GOVT. TIME TO TIME, THE DEPRIVED SCHEDULE CASTE PERSONS HAVE BEEN INCLUDED IN THE SCHEDULED CASTES ALSO.
