**Subject: "Mission LIFE" the 05 year plan to make 1 billion people of India pro planet by 2028 and commitments before United Nation Framework Convention on Climate Change (UNFCCC) in COP 26 held on 31 October to 13 November 2021 in Glasgow(UK).**

In the Conference of Parties (COP26) to UNFCCC held in Glasgow(UK) 31 October to 13 November 2021, which was attended by the Hon'ble Prime Minister of India Sh. Narendra Modi wherein the India shared the mantra of LIFE -Lifestyle for Environment - to combat climate change. India is the first country to include LIFE in its Nationally Determined Contributions (NDCs) .

Further, in continuation the Hon'ble Prime Minister Shri Narendra Modi attended a bilateral meeting with UN Secretary-General, H.E. Mr Antonio Guterres and subsequently launched Mission LIFE at the Statue of Unity, Kevadia, Gujarat on October 20, 2022. During the launch, the Prime Minister remarked, "The mantra of Mission LIFE is 'Lifestyle for Environment'. It connects the powers of the people for the protection of this earth and teaches them to utilise it in a better way." Elaborating further, he said, "Mission LIFE makes the fight against climate change democratic, in which everyone can contribute within their capacity. It inspires us to do all that can be done in our everyday life to protect the environment."

The objective of Mission LIFE is to translate the vision of LIFE into measurable impact. Mission LIFE is designed with the objective to mobilize at least one billion Indians and other global citizens to take individual and collective action for protecting and preserving the environment in the period 2022 to 2027. Within India, at least 80% of all villages and urban local bodies are aimed to become environment-friendly by 2028. It aims to nudge

and communities to practice a lifestyle that is synchronous with nature and does not harm it. Those who practice such a lifestyle are recognized as 'Pro Planet People'.

In the year 2023, Mission LIFE will focus on Phase I, Change in Demand, by nudging individuals, communities and institutions to practice simple environment-friendly actions (LIFE actions) in their daily lives. In view of Mission LIFE being launched in the 75th year of India's independence, a comprehensive and non-exhaustive list of 75 individual LIFE actions across 7 categories is identified. The digital copy of the booklet issued by NITI AYOG about mission LIFE including the non exhaustive list of 75 nos actions.

You are requested to circulate the above digital copy carrying 75 actions with all the offices at District Level with directions to further disseminate the same and to display the relevant actions plan in their offices. You are also requested to hold the meeting of District level officers for the fulfillment of the above purpose.

You are also requested to ask all the government offices under your jurisdiction to use the Mission LIFE logo on their letter heads and also use the relevant actions and logo of Mission LIFE in the various programmes organized by the Government Offices.
