RESOLVED THAT ALL THE CANDIDATES WHO HAVE NOT QUALIFIED PET EARLIER MAY BE GIVEN CHANCE TO APPEAR FOR PET AGAIN AND FOR THAT PURPOSE THE TEST MAY BE CONDUCTED BY THE DEPARTMENT ON 09.09.2023 AND THE RECOMMENDED CANDIDATES MAY BE CONSIDERED FOR ADMISSION ON ACADEMIC MERIT BASIS AGAINST THE VACANT SEATS. HOWEVER, THOSE CANDIDATES WHO HAVE GIVEN ENTRANCE TEST AND QUALIFIED PET MAY BE CONSIDERED FIRST.

SPECIAL COUNSELLING FOR SUCH CANDIDATES MAY BE CONDUCTED ON 12.09.2023 AND THE STUDENTS RECOMENDED FOR ADMISSION ARE REQUIRED TO SUBMIT THE FEE UPTO 13.09.2023.

2. Considered the request made by the Director, UIET on 29.08.2023 for extension of last date for submission of Online Application Form for M.Tech. programs as the application forms have exhausted and the seats are still lying vacant.



State Government, as precautionary measures, clamped curfew in all the Valley Districts as well as few affected Hills Districts of Manipur followed by suspension of internet facility in the State. Meanwhile, many students who are pursuing their studies/higher studies/professional courses in different Schools/Colleges/Universities in your State have been experiencing untold miseries to meet their day-to-day requirements coupled with expenditure pertaining to their study-related expenses.

While making such admissions, the Heads/Directors of the Departments/Institutes shall ensure that the Reservation Policy of the State Govt. is strictly followed.

- 1st Special round of Counselling: 18.08.2023 (fee submission upto 19.08.2023)
- 2nd Special round of Counselling: 21.08.2023 (fee submission upto 22.08.2023)
- 3rd Special round of Counselling: 31.08.2023 (fee submission on the same day)

- i. The vacant seats (except supernumerary category), if any, be converted to open seats by the Head/Director at own level on 31.08.2023, if no applicant of reserved category is available on that day.
- ii. Final cut off date for admissions is 31.08.2023.
