PROCEEDINGS OF THE MEETING OF THE COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 2.11.2017 AT 3.00 PM IN THE COMMITTEE ROOM OF THE VICE-CHANCELLOR'S OFFICE TO DISCUSS WAYS AND MEANS OF RESEARCH PROMOTION AND AUGMENTATION OF RESEARCH GRANTS IN MDU

At the outset, the Vice-Chancellor welcomed the members and discussed the issues as to how more and more grants can be availed from various funding agencies vis-a-vis UGC, CSIR, DST, ICSSR etc. etc.

During deliberations, it came to the notice of the Committee that the delay occurs in submission of individual research projects while routing through the Departmental Committees. Therefore, it was resolved that the individual projects be submitted well in time through the Head of the Department to the Director, Research. The Departmental Projects like SAP and FIST etc. be referred through the Departmental Committees only. Head of the Department concerned will ensure that the proposal being submitted is inconformity with the guidelines of the funding agency.

Besides above, the Committee recommends further as under:

 The Research Proposal(s) received by the Director, Research be got evaluated by the Committee consisting of Director Research, Dean of the Faculty concerned, Head of the Department and one senior Professor from the respective department and the teacher concerned. The power of nomination of the Professor shall remain with the Director, Research herself/himself. In case, there is no Professor in the concerned

department, the same can be got nominated from any of the allied departments. Three will form the quorum. The meeting of the said committee be convened in the office of Director, Research.

- 2. It was also resolved that each Department will get a Display Board prepared on which all information of the respective departments regarding number of major research projects undertaken by the teachers in order of seniority shall be displayed. This Board will also contain the information regarding research papers highly cited, which have been written by the Professors of the Department.
- 3. Each department shall also display in front of the department mentioning therein whether it is a SAP Department, FIST Department etc. etc. on the top of the building.
- 4. The Vice-Chancellor asked the Deans of the Faculties and the Director, Research to take immediate initiative for augmenting the research on the Campus and fetch maximum grants from the various agencies of the Government of India. The meeting ended with a vote of thanks to the Chair.
